

## Rights of interment

- ❧ Rights of interment purchased in Greenlawn Memorial Gardens are subject to the Restrictions and Conditions, which may be amended.
- ❧ Rights of interment may be sold or transferred with the consent of Greenlawn Memorial Gardens. Owner is responsible to notify cemetery authority upon sale, transfer, donation or inheritance in order to properly record such in cemetery records. Transfer fee as well as difference in Perpetual Care is due and payable to complete transaction.
- ❧ No use, division or improvement may be made without the approval of Greenlawn Memorial Gardens.
- ❧ All opening and closings for the burial of human remains will be performed by Greenlawn Memorial Gardens.
- ❧ Disinterment may be made with permission from the proper authority, and will be performed by Greenlawn Memorial Gardens.
- ❧ All ground interments shall require a vault.
- ❧ Interment rights within Gallant Fields section are restricted to honorably discharged U.S. Veterans and their spouses.

These Rules and Regulations are founded upon the idea that all persons with a right to inter in Walters Funerals, LLC, d/b/a Greenlawn Memorial Gardens (hereafter “Greenlawn Memorial Gardens”) are entitled to a dignified, safe, and peaceful atmosphere. They apply to all who enter the cemetery and may change without notification.

## General Rules and Regulations

- Access to and from the cemetery is only by use of the entrances furnished by Greenlawn Memorial Gardens. Private roadways in the cemetery are for funeral attendance and visitation.
- Automobiles, bicycles, motorcycles, and other vehicles not heavier than five tons shall be permitted while in the attendance of a funeral, visitation, or business in the cemetery and shall be driven solely on the roadway and in a manner which provides for the safety of persons and property.
- Visiting hours are between the hours of 7:00 a.m. and 6:00 p.m.
- Children, pets, and service dogs must be accompanied by adults while visiting in the cemetery.
- Solicitation of any kind, signs, notices, or advertisements will not be permitted within the cemetery.
- Property owners will be responsible for compliance with all possible future policies or fees.

## Memorials

- Memorials cannot be installed until all cemetery charges are paid in full.
- Memorials must be approved by cemetery authority according to section requirements. Below ground sections allow flat bronze with or without vase mounted on flat granite base 4-6 inches in thickness. Granite memorials and vases are allowed in above ground section. Gallant Fields is restricted to the government issued upright white marble headstones for the veteran, and the flat bronze marker on a white marble base for the spouse.
- Cemetery authority reserves the right to regulate the site of all markers, monuments and other construction of any grave or lot in said cemetery and to prevent the erection of any monument or obstruction which may conflict with the regulations or which may detract from the general appearance of the grounds and to remove the same if necessary. Non-regulation items will be discarded.
- Vesper lights and porcelain portraits are allowed. Other regulation ornamentation cannot exceed height of vases and must be attached to bronze or granite.
- Greenlawn Memorial Gardens is not an insurer; it will not be responsible for the loss, theft or damage to any item that may be placed on or in connection with a memorial, whether said item is placed with or without Greenlawn Memorial Gardens’ permission.

## Care of Cemetery Grounds

- Care of cemetery grounds is assumed by cemetery under the perpetual care trust agreement.
- Landscaping shall be the exclusive responsibility of cemetery employees except where permission is otherwise granted by the superintendent of the cemetery.
- Landscaping and features are property of Greenlawn Memorial Gardens and cannot be removed.
- Greenlawn Memorial Gardens reserves the right to make and change rules and regulations pertaining to use or beautification of the cemetery.

## Flowers and Wreaths

- Flowers brought to the grave from the funeral home will be removed within two days following burial.
- Floral tributes are allowed in regulation vases only, which can be purchased through the cemetery. Floral tributes will be removed once unsightly.
- Other items not approved by Greenlawn Memorial Gardens cannot be placed within the cemetery.
- Wreaths or special arrangements not in regulation vases are allowed only in observance of special days and will be removed once unsightly.
