Message from the Associate Administrator

Dear Transit Colleagues:

Happy New Year, everyone. I hope you had a chance to recharge for the year ahead. As we begin 2026, I'm encouraged by the progress we've established together to strengthen safety for transit workers and riders, use data to inform decisions and expand engagement across the industry.

A major accomplishment of this past year was the implementation of the Roadway Worker Protection (RWP) final rule. Implementing this regulation strengthens safety for everyone working on or near the tracks, and the efforts rail transit agencies took to implement these safety measures greatly advances our shared safety mission.

FTA also provided reminders in Safety Bulletin 25-1 on transit agency reporting to the National Transit Database (NTD). Each agency's continued commitment to timely reporting makes a real difference in advancing transit safety nationwide.

Looking ahead to 2026, FTA will continue emphasizing safety and security as we move closer to global events like the 2026 FIFA World Cup and the 2028 Olympics, both hosted by the United States and requiring massive support from the public transportation industry. FTA released a [Major Event Playbook](#) for transit agencies, which offers a practical guide, strategic insights, and key considerations to help public transportation agencies navigate federal transit requirements related to hosting major events.

Finally, a reminder that State Safety Oversight Agencies and Rail Transit Agencies should be aware of the Public Transportation Safety Certification Training Program (PTSCTP) semi-annual reporting period that runs from January 1–31, 2026 during which the designated Point of Contact (POC) must submit documentation to FTA.

FTA Issues Safety Advisory 25-1: Reducing Rail Trespassing and Suicide Events

On November 24, 2025, FTA issued a [safety advisory](#) focused on reducing fatalities and injuries from rail trespassing and suicide events. Trespass- and suicide-related events have been steadily increasing in the transit industry and are the leading source of transit-related fatalities, accounting for 50 percent of all fatalities reported to the National Transit Database in calendar year 2024.

The safety advisory recommends that State Safety Oversight Agencies (SSOAs) direct Rail Transit Agencies (RTAs) within their jurisdiction to perform the following related to rail trespassing and suicide events:

- Review and analyze safety performance data to identify hazards,
- Perform safety risk assessments,
- Identify safety risk mitigations as necessary to reduce safety risks and
- Monitor implemented mitigations for effectiveness.

FTA recommends that SSOAs that obtain such analyses from their RTAs upload completed safety risk assessments and associated safety risk mitigations from their RTAs to the State Safety Oversight Reporting (SSOR) system. FTA requests that any documents be uploaded within 180 days from the issuance of this Safety Advisory. Transit Agencies' Efforts to Address Substance Use and Strengthen Community Safety

Across the country, agencies are implementing innovative programs and partnerships to prevent substance use and misuse and respond effectively to emergencies.

The Pinellas Suncoast Transit Authority (PSTA) in St Petersburg, Florida became the state's first transit agency to deploy Narcan emergency kits at all bus terminals and offer voluntary Narcan training in partnership with the Pinellas County Health Department and a retired narcotics officer. PSTA expanded the effort to include 600 Narcan kits to be placed on every bus, integrated Narcan training into new operator onboarding and equipped its headquarters with kits alongside AEDs and first aid stations.

Similarly, the Tri-County Metropolitan Transportation District of Oregon (TriMet) has more than doubled its safety and customer service staff to over 450 personnel

working to encourage a positive riding experience. TriMet's Safety Response Team provides on-the-ground outreach, connecting individuals to housing and addiction services while carrying supplies like Narcan, which it administered at least 49 times in 2025 alone. TriMet's 24-hour Security Operations Center and rider hotline cut response times by 30 percent and increased threat prevention by 40 percent. These efforts, along with continued collaboration with law enforcement to curb open drug use on and around transit, have significantly improved safety, reducing reports of drug-related smoke or fumes by more than 80 percent on buses and over 90 percent on light rail since early 2023.
