I fully understand the risk and dangers associated with my participation in this hunting activity and ACCEPT SAME ENTIRELY AT MY OWN RISK.

I hereby WAIVE ANY AND ALL CLAIMS which I may have against "The Outfitter" and "The Outfitter" Employees and RELEASE "The Outfitter" AND EMPLOYEES from ALL LIABILITY for injury, death, property damage or any other loss sustained to me a result of my participation in this hunting activity, DUE TO ANY CAUSE WHATSOEVER including without limitation, negligence on the part of "The Outfitter" or "The Outfitter" Employees. I further AGREE TO INDEMNIFY "The Outfitter" and "The Outfitter" Employees for any and all legal fees (on a solicitor and his own client basis) or costs which may be incurred in defending any lawsuit or claim I bring against them.

I appreciate that This Agreement applies whether "The Outfitter" is at fault or not and it limits the liability of "The Outfitter" Employees to the same extent as it limits the liability of "The Outfitter" even though "The Outfitter" Employees are not formal parties to this Agreement.
