Giving is a personal decision. United Way of the Piedmont strongly discourages and works to eliminate coercion of any kind in the solicitation process. No goods or services were provided in exchange for this contribution. Should you have selected payroll deduction as the payment method for fulfilling your gift, your employer is responsible for withholding those funds from your pay. Your employer is also responsible for sending those withholdings to us in a timely manner. You may need a copy of your final pay stub, W-2, or other employer document showing the amount withheld and paid to a charitable organization for tax purposes.
