This quarter has been and always will be the busiest time in our Christian faith. It is also the month which requires make us to some introspections in our personal lives and also in our roles as leaders of the young ones. As I pen down this article, it strikes me that today, the 25th of March, we should be celebrating "The Annunciation of our Lord to the Blessed Virgin Mary", also known as Lady Day. Lady Day is one of the most important events that are celebrated by the Mother's Union and as we know, GFS is tied at the hip to the Mother's Union.

This has led me to have an interest and look at the MU's theme for the 2019 which is: Listen, observe, act in with God. step https://www.mothersunion.org/resourc es/2019-theme-listen-observe-actstep-with-god). In their bible reflections, they have chosen 2 verses for each of the theme's elements as I have listed them below for each of us to find and meditate on them.

Jesus listens: *Mark* 1:40-42 **&** *Matthew* 20:30-34

Jesus observes: Matthew 14:13-14 &

Matthew 9:36-10:1





Jesus acts:

Whenever Jesus listened and observed it led to action

- Consider the different ways Jesus acted in response to what he heard and observed, and his motivation for his actions
- Reflect on the qualities that we do or should display as we respond to what we hear and observe
- What can we learn from Jesus' actions as to how we can reach out to the needs of the crowds (engage with our wider community?)

When South Africa was handed the responsibility of hosting the 2020 GFS World Council, somehow in my mind, and I admit that also with my team, we thought that we had ample time to pull everything together. Beginning of this year, we realised that we are only left with 18 months and as you receive this newsletter the 18 has become 15 months. We hope that this will be a wake-up call for those who have not vet started with their fundraising drives to be part of the African experience! Towards end of last year, we had requested countries to send us estimated numbers of delegates who might be attending council and this we understand would be a challenge for many countries. We are hoping that with the conference fees being declared and application forms having been sent out beginning of March 2019, we will be getting some feedback in the next quarter. We do hope that by now all branches have received the application form with the information sheet.

During this quarter we have also seen some of the South African branches renewing their commitment to the GFS cause by launching Orange Day, having Gender-Based Violence workshops and making a pledge to be good stewards by taking better care of the environment in their respective areas.

In our daily lives, we take out insurances for different eventualities but in so doing, there is always a clause stating - Acts of God provisions, also called "Force Majeure". This clause has become a reality for people affected by Cyclone Idai in Mozambique, Malawi and Zimbabwe between 3 and 21 March 2019. It is recorded that approximately 122 deaths occurred in Malawi and Mozambique from the flooding that preceded Idai's second landfall; and at least 402 deaths occurred in Mozambique and 259 in Zimbabwe after Idai made its second landfall. Let us continue to keep these countries in our prayers during the mop-up period and as they start to rebuild their lives. We hope to hear from our Mozambique national president how Cyclone Idai has impacted GFS areas and her work in the country.

Christchurch massacre has been the latest shock to the world and should be raising our conscience as Christians as to what are we saying about these attacks? We have seen these faith-based related intolerances taking place in different parts of our world. What message are we passing on to the girls and boys we are raising going into the future? They go to schools, grow up playing with all these diverse religions. What goes through their minds when such incidents happen? If we say we offer our prayers, is that enough? What are our actions to curb such intolerance?

During this time of Lententide, let us find ourselves, listen attentively to what God is saying to us, observe what is happening around us, the people we live with, within our churches, in the world and the impact we are making to our environment and most of all look at our actions. What do our actions say about us? Let us ask ourselves whether we are true to our own theme "bear one another's burdens, so as to fulfil the law of Christ"?



WORLD STRUCTURE

These are the two final clauses in our Rules of Management. There have been many emergencies throughout our world and country leaders should be aware of the fund and the guidelines which would allow GFS Country leaders (through their Archbishop) to apply for emergency funds. We need more donations to the fund so that we are ready should the need arise.

The Web page is only as good as the information provided. I would ask all country leaders to read the information about their country and update me with information. (Please note that the five new countries of DRC, Malawi, Tanzania, South Sudan and Zimbabwe are not yet on the web but I would appreciate receiving information so I can complete these pages. Note also the requirement regarding photos of childen under the age of 18 shown on our website. It is necessary for you to have the permission of the child's parent or guardian before submitting the photo for printing.

Rules of Management for GFS Worldwide.

9.1 World Emergency Relief Fund

The purpose of the World Emergency Relief Fund is to assist GFS member countries with funding of emergency relief efforts in their countries in times of crisis, extreme circumstances, or natural disaster.

- Funds can be distributed in response from a member country in need, or at the discretion of the World President in consultation with the World Executive or World Team
- Requests must be made in writing by a member country's GFS President/Chairman in liaison with

their appropriate Bishop. The request shall include a description of the need and relief sought. All requests are to be received by the World President. Other members of GFS, who see a need are to be encouraged to contact their country's GFS President/Chairman, who can in turn contact the World President.

- Upon receipt of a request, the World President will immediately advise all member countries of the need and opportunity to donate to the fund.
- The account will be funded by donations. Up to 50% of the fund can be accessed for any single request until the funds are replenished. Upon replenishment additional funds can be disbursed.
- In most instances, requests for World Emergency Relief Funds will be seeking funds urgently. To ensure funds are received when needed most, the GFS World President will immediately seek advice and endorsement from the GFS World Team to provide funds.
- The World President/World Treasurer shall disburse the funds to the requesting GFS member country's President/Chairman in conjunction with their Treasurer.
- Member countries given World Emergency Relief Funds shall provide the World President with a written acknowledgement of the receipt of the funds and a description of how the funds were used within six (6) months of receipt of the monies.
- Countries receiving funds will present a brief report on the use of these funds at the World Council that immediately precedes the request and receipt of these funds.

GFS World Website The World Council will mana

The World Council will manage and maintain a GFS world





website.

- 1. The purpose of the GFS world web site is:
- To promote the organization GFS, its purpose and ministries throughout the world, by providing information about GFS' history, structure, rules and policies and current activities.
- To encourage new membership by providing a link to the World President for further information.
- To provide a link between current GFS countries with prayer information, newsletters and dissemination of information.
- To provide access to web pages and contact information for GFS member countries.

1. Maintenance of Website.

The incumbent GFS World President will maintain a domain host, list a web name and pay all costs from the GFS World operating account to maintain the website.

- The responsibility for maintaining the website will rest with the current World President but may be delegated to another country with the skills to maintain the website.
- This decision will be made by the World President, in conjunction with the incoming World President when the next host country is approved.
- From 4 August 2014 to 19 July 2017 the registered domain will be <u>www.gfsworld.org</u> and will be managed through GFS Australia Inc.
- The host country or the country maintaining the website on behalf of the host country will appoint a Webmaster who will hold the necessary skills to maintain the website. Such appointment must

be approved by the current World President.

10.3 World Website Information.

- Member countries of the World Council have an obligation to ensure that any information on the website pertaining to their country is kept up to date.
- Member country
 Presidents/Chairmen should appoint a member within their own country to liaise with the World Webmaster to ensure that there is a regular review of the information relating to their country.
- Any photos of children (under the age of 18) will only be posted to the website if the President/Chairman of the country providing the photo can assure the World Webmaster that permission to post the photo has been obtained from the parent or guardian of the child/children. A process should be in place in each country to ensure this permission.
- The names of children under the age of 18 will not be used on the GFS website or within the GFS World Newsletter unless express written permission has been provided by the parents/carers of that child/children. Names of children under the age of 18 will only be used where relevant to a specific story.
- As the World newsletter is posted to the World Web page the permission to use a photo of a child/children should also be included when submitting articles and photos to the World President for use in the World newsletter.

WORLD COUNCIL JULY 2019 INFORMATION SHEET

If you intend to register to attend World Council in South Africa you should read this Information sheet carefully.

REGISTRATIONS CLOSE ON 31 OCTOBER 2019

World Council will be held at ATKV Klein Kariba Lodge, Bela-Bela which is 1-hour drive from Pretoria and 1.5-hour drive from Johannesburg. The website is https://klein-kariba.co.za. No enquiries are to be made to the Conference Centre. All enquiries are to be made through Pumeza Magona – gfsworldsec2020@gmail.com.

1. TRANSPORT ARRANGEMENTS:

All delegates are expected to either land at OR Tambo International Airport; Lanseria International Airport (domestic), Johannesburg Park Station and Pretoria Station. Shuttles will be arranged based on arrival times at these various arrival points and taken to Emseni Christian Centre. (*Please see NOTE 13 for detailed information*)

2. TO REGISTER:

Complete the paper-based form and return via e-mail with copy of your **Passport** and or **Identity Document** to gfsworldsec2020@gmail.com.

3. COST OF COUNCIL:

Total cost of Council is R13,500 (South African Rand). Deposit of R5 500 must be paid before 31 October 2019 to enable registration to be accepted. Second payment of R8,000 due by 31 March 2020 (or full payment can be made at registration).

4. APPROVAL FROM YOUR COUNTRY LEADER

Your country leader must sign the Registration form and/or send an email/letter to gfsworldsec2020@gmail.com confirming that you are a GFS member.

If you are under 18 – you require the approval of your country leader along with your parent/guardian to sign the form and provide the details of the person who will be

responsible for your care while you are at World Council.

5. BANK ACCOUNT DEPOSITS:

The GFS World Account details are on the form and you can organize a bank transfer. Make sure that you describe your payment as **SURNAME WC2020**. It is important your surname comes first as often banks truncate this information.

Once your registration is processed you will be sent a Medical Information Sheet. This must be completed in full, placed in a sealed envelope with your name and country on the front (in large letters) and brought to Council. It will be kept sealed and in a secure place during Council. It will only be opened in an emergency and will be returned to you at the completion of council.
