

SPECIAL SERVICES

FORWARDING OF REMAINS TO AN OUT OF TOWN FUNERAL DIRECTOR

This charge includes Removal of remains from place of death (locally), Basic Professional Services of Funeral Director and Staff, Overhead Expenses, Securing all necessary Authorizations, Death Certificates, Permits and Consents, etc., Embalming and Transportation to Railroad or Airport. It does not include* Shipping Receptacle, Use of Facilities for Viewing and/or Funeral Service. It does not include Airfare or Railroad Charges.

Forwarding Of Remains \$2,095

RECEIVING REMAINS FROM OUT OF TOWN FUNERAL DIRECTOR

This charge includes Removal of remains from Railroad or Airport (locally), Basic Professional Services of Funeral Director and Staff, Overhead Expenses, Securing all necessary Authorizations, Death Certificates, Permits and Consents, etc., It does not include hearse, limousine or use of facilities for Viewing and/or Funeral Service prior to Final Disposition.

All funeral arrangements must be paid in full before final disposition.

Receiving Remains \$1,895

GRAVESIDE SERVICE

This charge includes Removal of remains from place of death (locally), Basic Professional Services of Funeral Director and Staff, Overhead Expenses, Securing all necessary Authorizations, Death Certificates, Permits and Consents, etc. , Other Preparation, Use of Funeral Home as a place of assembly and point of departure to cemetery, Hearse to cemetery and one hour service at graveside. It does not include a Viewing, Embalming, Purchase of a Casket, Vault, Alternative Container, Limousine or Public Viewing prior to Final Disposition and Cemetery Charge.

Graveside Service \$3,800

DIRECT BURIAL

This charge includes Removal of remains from place of death (locally), Basic Professional Services of Funeral Director and Staff, Overhead Expenses, Securing all necessary Authorizations, Death Certificates, Permits and Consents, etc., Hearse to Cemetery, and Brief Committal Service at Grave site. It does not include a Limousine, Purchase of a Casket, Vault, Alternative Container or Cemetery Charge. It does not include a public viewing prior to final disposition.

Direct Burial \$3,800-\$5,268

JANAZAH SERVICE

This charge includes Removal of remains from place of death (locally), Basic Professional Services of Funeral Director and Staff, Overhead Expenses, Securing all necessary Authorizations, Death Certificates, Permits and Consents, etc., Materials for shrouding and transportation for deceased to cemetery. It does not include limousine, Iman or pine box.

Janazah Service \$4,575

DIRECT CREMATION

This charge includes Removal of remains from place of death (locally), Basic Professional Services of Funeral Director and Staff, Overhead Expenses, Securing all necessary Authorizations, Death Certificates, Permits and Consents, etc. Transportation Directly to Crematory. It does not include a Limousine,Public viewing, or private viewing of your loved one, or embalming prior to cremation.

Direct Cremation \$1,500-3,500

(Note: Pennsylvania Rules and Regulations No. 13.201 6(i) requires that any human remains held 24 hours beyond death shall be embalmed or sealed in a container that will not allow fumes or odors to escape or kept under refrigeration, if this does not conflict with a religious belief or medical examination.)

Embalming after 24 hours and prior to Cremation \$995

If you want to arrange a Direct Cremation, you can use an Alternative Container. Alternative Containers are comprised of materials such as an Unfinished Wood (Pine Box) or Heavy Fiberboard.

INFANT SERVICES UP TO 15 MONTHS

These charges are based upon the length, weight and condition of the remains. Decision is made on a case by case basis. Professional Services Includes: Removal of remains to the funeral home, embalming and preparation of the body, dressing, casketing and cosmetology. This DOES NOT INCLUDE casket coach or limousine.

BASIC SERVICES

OF FUNERAL DIRECTOR AND STAFF

(NON-DECLINE-ABLE AND NON-REFUNDABLE)

Our professional charges include, but are not limited to availability on a 24 hour basis, Counseling, Consultation with Family and Clergy, Assistance of Staff in all necessary phases of Arrangement, Securing, Preparing and Filing of all Necessary Authorizations, Consents, Death Certificates and Acquiring Permits; Coordinating with persons providing ancillary portions of the Funeral, such as Cemetery, Clergy, and Others, Use of Preparation Room, Supervising all arrangements pertaining to the Funeral, Memorial Service and Final Disposition. Also included in this charge are Overhead Expenses relative to our facilities such as Professional Licensing, Legal and Accounting Fees, Insurance, Building and Utility Expenses, Parking Grounds, Maintenance, Taxes, Equipment, Inventory Costs, Record Keeping and Administrative Expenses, etc. (This fee will be added to the total cost of the funeral arrangements you select.) This fee is already incorporated in our charge for Direct Cremation, Immediate Burial, Graveside Service, Forwarding and Receiving Remains from Out of Town Funeral Director.

Professional Charges \$2,500

EMBALMING

Except in certain special cases, embalming is not required by law. Embalming may be essential, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you have the right to choose an arrangement that does not require you to pay for embalming, such as direct cremation, graveside services.

ADDITIONAL FEES

Supervision by Licensed Funeral Director \$250

(Supervision of Funeral Director for the Duration of the Interment or Inurnment of Cremains)

Section13.215 - Supervision or funeral service and interment: It shall be the responsibility of the funeral director in charge to personally supervise the funeral service at the cemetery and to have a representative present at the interment of the deceased. The records of the funeral director shall indicate who his representative was at the interment. 49 Pa. Code 13.215

Arrangement Conference \$725

If you complete the arrangement process, to include scheduling and facilitating the service and decide to cancel out services you will be charged to cover the time and professionalism of our staff.

OUR PAYMENT POLICY

Satisfactory arrangements for payment of Funeral Goods and Services selected must be paid at the arrangement conference or 48 hours before the scheduled service. We accept the following as a method of payment:

- Assignment of Insurance (subject to processing fee)
 - Certified Check
- All Major Credit Cards (subject to processing fee)
 - Money Order
- Funeral Financing (subject to processing fee)
 - Department of Public Welfare Grant

If Insurance Assignment is applied, Insurance Policies must be surrendered to the Funeral Director during arrangements to allow for verification with the Insurance Company. *If payment is executed from an Insurance Policy. 5% charge of the funeral amount plus a \$35.00 wire charge will be incurred.
