GENERAL PRICE LIST

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

These prices are effective JANUARY 1, 2026 AND are subject to change without notice.

BASIC SERVICES OF FUNERAL DIRECTOR, STAFF & OVERHEAD.....\$950

Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

EMBALMING.....\$725

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

FORWARDING OF REMAINS TO ANOTHER FUNERAL SERVICE.....\$1,955

This charge includes removal of remains, services of staff, embalming, necessary authorizations, local transportation. It does not include shipping and casket or container, visitation, funeral rites, ceremonies or car transport.

ANATOMICAL DONATION.....\$775

Our charge includes basic services of funeral director and staff, local transfer to funeral service, filing necessary documents and permits, and transportation to local medical facility

DIRECT BURIAL.....\$1,695

Our charge for an immediate burial includes local removal, care of remains, basic services of staff, securing proper permits and authorizations, and use of casket van to local cemetery. (It excludes casket, vault, ceremony, visitation, embalming, cemetery charges and other cash advances.)

DIRECT CREMATION.....\$1045

This includes: Basic services of funeral director and staff, local transfer of remains, transportation to crematory, cremation, alternative container and a temporary urn. Alternative containers encase the body and can be made of materials like fiber-board or composition materials (with or without an outside covering.) The containers we provide are heavy cardboard and leak resistant.

OPTIONAL: Add Witnessing of Cremation.....\$450

*No photography or video cameras permitted and all must sign a release and hold harmless agreement prior to witnessing.

OPTIONAL: Add Private Viewing for a Goodbye (per hour).....\$500

Bathing and disinfecting when no embalming, placement in chosen container and a time for immediate family to say their goodbye. 10 people maximum. This does not include additional services such as embalming, hair dressing or cosmetics. Additional attendance will result in full visitation and basic services and staff charges. No published announcement for private viewing.

OPTIONAL: Add Memorial Service.....\$800

Honor and memorialize the life of your loved one. In addition to services of Direct Cremation, assistance with designing a memorial service, optional placement of obituary (additional charge for newspaper print) and use of equipment.

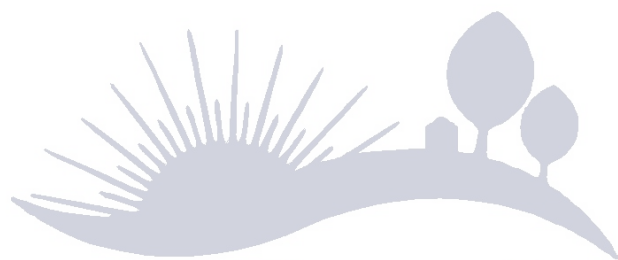

PAYMENT POLICY --Day Funeral Service operates on a cash basis, being totally dependent upon the families we serve for prompt payment by the day of funeral service. We have adopted the following payment methods to insure that we continue providing families quality service. Payment is expected by the day of funeral arrangements. We realize that losing someone you love is a devastating experience. It can be traumatic and influence the decisions that must be made. Therefore, it is important to be realistic with respect to funeral expenditures. It is our intention that your decisions reflect your personal wishes and remain within your budget. The following are acceptable payment arrangements: Cash. Checks are subject to electronic funds verification. Visa, MasterCard, Discover Card and American Express have a 2.75% surcharge. Assignment of Insurance proceeds from the beneficiary (upon verification from the Insurance Company.) There is a 4% processing fee to all insurance assignments and is payable to the third party processing factor. In the event that we extend credit for 30 days, we require two (2) signatures from individuals who will accept financial responsibility for the final funeral expenses. Parties must own real estate locally or have had the same stable job for over 2 years. A late fee of 1.5% (18% annually) will be charged per month on any unpaid balance. We reserve the right to seek legal action on accounts three (3) months past due.
