These prices are effective as of January 1, 2024 and are subject to change without notice. The goods and services shown below are those we can provide to our customers. You may choose only those items you desire. (However, any funeral arrangements you select will include a charge for our services and overhead.) If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

DIRECT CREMATION: \$1,395

Our charge for a direct cremation (without ceremony) includes: basic services of funeral director and staff; proportionate share of overhead costs; online cremation arrangements; removal of remains (within 20 mile radius, beyond is \$5 per mile); shelter of remains for 4 days; digital photo identification; transportation to crematory; necessary authorizations and cremation. Cremation will occur within 7-10 business days. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a fiberboard container, transporter cremation container or an unfinished wood box. A fee of \$200 extra will be added to a transfer of a decedent from a residence.

Additional Services which may be added to the services you select:

- Single Decedent Transfer from Place of Death and To the Crematory: \$150
- In person arrangements (M-F from 9AM-4PM in at Conroy-Tully Walker): \$750
- Expedited cremation (2-4 business days after receiving permit): \$500
- Shelter of remains beyond 4 days: \$100 per day
- Removal of pacemaker: \$95
- Over 300 pounds (to accommodate appropriate sized cremation container): \$300
- Shelter of remains at funeral home beyond 5 days: \$75 per week
- Cremated remains delivery within 20 miles of Portland (\$5/mile beyond): \$125
- Transfer from island: Additional \$150/hour
- Mailing of Cremated Remains: \$195
- Refrigeration at our affiliate, Carll-Heald and Black Funeral Home in Springvale: \$325
- Transfer of Remains to the Funeral Home (within 20 mile radius): \$795
 - beyond this radius we charge \$5 per mile
 - additional attendant for home transfer: \$200
- Other Preparation of the Body: \$500
 - Minimal preparation and dressing for Private Identification

- Basic Services of Funeral Director and Staff and Overhead: \$3,345
 - Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)
- Embalming: \$700
 - Except in certain cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

 - Our charge includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; preparation of remains [including embalming]†, and local transportation.
- Receiving Remains from Another Funeral Home \$3,500
 - Our charge includes: basic services of funeral director and staff; a proportionate share of overhead costs; care of remains; transportation of remains to funeral home and to cemetery or crematory.
- Immediate Burial: \$3,500 to \$5,500
 - Our charge for an immediate burial (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; and local transportation to cemetery.
