

CO-OPERATIVE RATE ENERGY CONTRACT

By signing this Product Sheet, the member listed below agrees to have North Parkland Power Co-op supply the Account(s), listed below, with energy in accordance with the included Additional Terms and Conditions, for the price and term as follows:

The term of this Contract will commence on the Start Date, or the first day of the following month post receipt of the fully executed Contract. Upon commencement, the Contract Price, Terms and Conditions will apply for the current year as indicated by the Start Date or for a period 12 months, whichever is the lesser of.

The **Start Date** of the Contract shall be **January 1, 2026**, or the first day of the following month after the contract is deemed to have been received. The Contract will be of a continuous nature and as such does not have a fixed contract end date. The Contract will continue to be renewed and the applicable Co-operative Rate Contract Price, as approved by the Board of Directors from time to time will apply until one of the parties in the contract terminates the agreement (see Additional Terms and Conditions below for requirements to terminate).

Please note: If Refuse Continuous Contract is selected, the **Expiry Date** of this Contract will be **December 31st, 2026**. If no further contract is executed, your energy supply will revert to the Rate of Last Resort (RoLR) The RoLR is decided by your Board of Directors and is in alignment with the Alberta regulatory authorities. The RoLR rate is **13.31 cents per kWh**.

Product Terms and Conditions

1. This contract may be terminated by either party, without penalty, with provision of 90-day written notice of termination.
2. Co-operative Rate Contract Price is subject to change, upon Board of Director approval, a minimum of one-month prior to coming into effect.
3. Members will be provided notice of any Contract Price change through either the billing process or direct mail, or both in addition to being posted on the North Parkland Power Co-op website (www.npprea.ca).
4. Early Exit Fee may be applied if the Contract is terminated, by the member, without 90 days' written notice. Early Exit Fee will be calculated as follows:
1.5 cent per kWh for each kWh of electricity usage for the remainder of the term applicable. The usage for the remainder of the term is calculated based on historical consumption (an average REA member will consume approximately 1,000 kWh of electricity per month).
5. The Member is and remains responsible for Other Charges as set out in the Terms and Conditions of Electric Distribution Service.
6. North Parkland Power Co-op may terminate this contract should your Account become more than 30 days in arrears.
7. You must be a member in good standing (per the co-operative bylaws) of North Parkland Power Co-op to be eligible for the Co-operative Rate. This includes but not limited to having a current North Parkland Power REA Electrical Service Contract, or a signed Terms & Conditions of Electric Distribution Service Acknowledgement Form, and a registered URW (Utility Right of Way) at Land Titles must be on file.
