1. Call meeting to order.
2. Public Comment: Individual members of the public may address the Board regarding general topics that are not on the current agenda. In accordance with the Texas Open Meetings Act, any response to a public comment that is made on an item that is not on the public final agenda will be limited to a statement of factual or a statement of existing policy given in response to the public comment. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda.
3. Public Comment on Agenda Items: Members of the public will speak on an agenda item after comments on the item are called for by the presiding officer, but before Board discussion and consideration of the item.

5. Receive monthly report from Fire Chief regarding financial matters, training, management activities, emergency operations and out of station times (including breakdown by apparatus) and call volume for fire/rescue calls and for EMS calls.
6. Receive update from Executive Director regarding management activities, communications, community events and other District matters.

10. Discuss and consider action on benefits for full-time employees starting October 1, 2026.
11. Discuss and consider service provider contract renewals and/or amendments.
12. Discuss and consider items needed for the November 2026 annexation election.
13. Discuss the agenda, time, and date for the next meeting.
