MINUTES OF THE MEETING HELD IN THE VILLAGE HALL, SHERIFF HUTTON ON FRIDAY 12th MARCH 2021 AT 7.30PM

1. APOLOGIES OF ABSENCE

2. DECLARATION OF INTERESTS

Cllr Caroline Goodwick declared an interest in Item 7 – Planning.

3. MINUTES

6. CLERK'S REPORT

- (a) A discussion took place regarding the necessary requirements for the council to meet the website accessibility regulations. It was agreed that, if necessary, the parish council would upgrade the website to a paid platform, at a cost of £240.00 per annum. Clerk to liaise with Bass Stewart.
- (b) The issue of dog fouling in the village was discussed. The parish council are working with Louise Chandler to produce a suitable flyer and a note to be added to the next Village News.
- (c) The letter received from a resident regarding tree planting in the village was discussed. After discussion, it was agreed that due to a number of issues, the parish council are not able to proceed with such a tree planting scheme. However, the parish council will look into, where practically, some trees could be planted in the village. County Councillor Caroline Goodrick advised that NYCC would not promote such tree planting on verges, due to issues with drains, telecoms, etc. She advised that NYCC will not take on the responsibility of any trees and issued strong advice against planting any trees on verges.
