This STALLION BREEDING CONTRACT for the 2026 breeding season is made and entered into on this ____ day, of _____, 2025 is by and between Ashley Day (Stallion Owner) and _____, (Mare Owner).

Mare Owner agrees to breed the mare, _____ Reg. No. _____ to the stallion, ArmedNFamous Reg. No. 6392424 for the stallion fee of \$__2500____, for a live foal, subject to the following conditions: **Deposit of \$500 returned with contract..** Please make fees payable to Radley or Ashley Day.

The Stallion Owner’s Veterinarian (veterinarian) for the 2026 breeding season is: Dr. Dallas Shaw at 88 Equine at 3367 Upper Powder River Road in Buffalo, WY 82834. Collection for ArmedNFamous will be March 1, 2025- June 20th, 2025, unless other arrangements are made.

Shipped Semen: “King” is still competing, however, our goal is to ship cooled semen primarily. If frozen semen is preferred or if he is unavailable for collection, frozen semen will be available. [PHONE NUMBER FOR ORDERING SEMEN: 88 Equine \(307\) 621-1860](tel:3076211860)

1st Shipment Chute Fee (Standard Overnight Delivery): \$500

2nd Shipment is only shipping (no chute fee)

Local Pickup: \$150

Counter to Counter Airline Shipment and Frozen Semen Shipment: \$500

Normal shipping days for Veterinarian are: Monday, Wednesday and Friday throughout breeding season. Semen orders will be requested by 5 pm MST the day prior to semen collection and canceled by 8 am MST the day of collection. All semen containers MUST be returned within 5 business days of receipt. If the container is not received within 5 business days the mare owner shall pay a NON-RETURN fee of \$50.00.

General Conditions:1. This contract contains a “Live Foal Guarantee”. A live foal is described as a newborn foal, which stands and nurses without assistance. If foal is born dead, there are return privileges for the following breeding season only if Breeder is notified within 5 calendar days. If after being pronounced “safe in foal”, the mare should miscarry, abort or prove barren, Mare Owner has the privilege to return her for breeding during the current breeding season or the following year. Mare owner shall be responsible for all cost (shipping fees) associated with rebreeds. [There will be a \\$300 Rebreed Fee for rebreeds the following year.](#) 2. A “Breeders Certificate” will be issued for the foal conceived by this mating when stallion fee and all other expenses have been paid in full. 3. Should the stallion die, be sold by the owner, or become unfit for service prior to settling the mare, this contract shall become transferred to frozen semen, for 1 year. 4. This Contract is non-assignable and nontransferable. This Contract is entered into in the State of Montana and will be interpreted and enforced under the laws of that state. This Contract represents the entire agreement between parties. No other agreements or promises, verbal or implied, are included unless specifically stated in this written Contract. When Mare Owner and Breeder sign this Contract, it will then be binding on both parties. 5. Every attempt will be taken to deliver the semen to the mare owner in good condition, but once shipment leaves 88 Equine, they cannot be held responsible for untimely delivery or the condition of the cooled semen. I am also aware that the on site mares will receive priority, and all Shipped Semen mares will be served on a first order, first served basis if necessary, therefore there is No Guarantee that semen will be available for any specific day.
