2026 CONTRACT FOR SMOKE N SUNRISE



This STALLION BREEDING CONTRACT for the 2026 breeding season is made and entered into on this ____ day, of _____, 2026 is by and between Joey Williams (Stallion Owner) and _____, (Mare Owner).

Mare Owner agrees to breed the mare, _____ Reg. No. _____ to the stallion, Smoke N Sunrise, Reg. No. 5476809 for the stallion fee of \$__1500__, for a live foal, subject to the following conditions: **Stallion fee deposit/Booking fee of \$350 must be returned with contract, must be paid in full before first shipment.** Make fees payable to Joey Williams.

The Stallion Owner’s Veterinarian (veterinarian) for the 2026 breeding season is: Dr. Dallas Shaw at 88 Equine at 3367 Upper Powder River Road in Buffalo, WY 82834. Collection for Smoke N Sunrise will be April 1, 2026- June 15 , 2026, unless other arrangements are made.

Shipped Semen: Our goal is to ship cooled semen. If frozen semen is preferred or if he is unavailable, frozen semen will be available.

1st Shipment/Chute Fee \$500

2nd Shipment \$400

Local Pickup \$150

Counter to Counter and Frozen Semen Shipment: \$500

Normal shipping days for 88 Equine are: Monday, Wednesday and Friday throughout the breeding season. Semen orders will be requested by 5 pm MST the day prior to semen collection and canceled by 8 am MST the day of collection. To order semen call 88 Equine at (307)621-1860. All semen containers MUST be returned within 5 business days of receipt. If the container is not received within 5 business days the mare owner shall pay a NON-RETURN fee of \$50.00.

General Conditions:

1. This contract contains a “Live Foal Guarantee”. A live foal is described as a newborn foal, which stands and nurses without assistance. If foal is born dead, there are return privileges for the following breeding season only if Breeder is notified within 5 calendar days. If after being pronounced “safe in foal”, the mare should miscarry, abort or prove barren, Mare Owner has the privilege to return her for breeding during the current breeding season or the following year. Mare owner shall be responsible for all cost (shipping fees) associated with rebreeds. **There will be a \$300 Rebreed Fee for rebreeds the following year.** 2. A “Breeders Certificate” will be issued for the foal conceived by this mating when stallion fee and all other expenses have been paid in full. 3. Should the stallion die, be sold by the owner, or become unfit for service prior to settling the mare, we will offer the following option. Breeder has the option of up to two doses of frozen semen to be released one dose at a time. After two attempts the contract will be considered fulfilled. 4. This Contract is non-assignable and non transferable. This Contract is entered into in the State of Montana and will be interpreted and enforced under the laws of that state. This Contract represents the entire agreement between parties. No other agreements or promises, verbal or implied, are included unless specifically stated in this written Contract. When Mare Owner and Breeder sign this Contract, it will then be binding on both parties. 5. Every attempt will be taken to deliver the semen to the mare owner in good condition, but once shipment leaves 88 Equine, they cannot be held responsible for untimely delivery of the condition of the cooled semen. I am also aware that the on site mares will receive priority, and all Shipped Semen mares will be served on a first order, first served basis if necessary, therefore there is NO guarantee that cooled semen will be available any specific day.
