Stallion Service Contract

This certifies _____ herein referred to as the Mare Owner has engaged one breeding to Still Get Jealous for the 2026 breeding season. For the following mare: Mare Name _____ Registration No. _____ for the stallion fee of _____ that must be paid prior to shipment.

88 Equine/Riverside LLC, agent for the above named-stallion, will herein be referred to as the Manager. **This service is engaged subject to the following:**

1. **Breeding to Stallion:** Mare Owner agrees to breed Mare to ("Stallion"), during the 2026 breeding season on the terms and conditions set forth in this Agreement. Mare Owner agrees to deliver to Manager a photocopy of both sides of the Mare's registration papers on or before the Effective Date. The breeding season for Stallion shall be from February 1, 2026 to July 15, 2026. (Unless other arrangements are made).

2. **Term:** This Agreement shall commence on the Effective Date.

3. **Fees:** In exchange for breeding Mare to Stallion, Mare Owner shall pay the fees set forth below (by check, money order or credit card).

a) **Booking/Chute Fee:** Mare owner shall pay \$500 as the non-refundable chute fee to Manager on or before the Effective Date of this Agreement. Chute fee includes UPS/FedEx shipping and first collection. In house mares will not pay \$500 Chute fee. Instead, they will pay \$150 plus mare care for breeding in-house.

b) **Stallion Fee:** If mare is to be bred with shipped semen, I understand that the Stallion Fee must be paid in full before any semen will be shipped. If the mare does not settle on the first insemination, I agree to pay a fee of \$450 per Standard Overnight Delivery, \$150.00 for each local pickup, \$500 per Counter to Counter Airline Shipment, or \$500 for each frozen semen shipment. Every attempt will be taken to deliver the semen to the mare owner in good condition, but once shipment leaves 88 Equine, they cannot be held responsible for untimely delivery or the

condition of the cooled semen. I am also aware that the on site mares will receive priority, and all Shipped Semen mares will be served on a first order, first served basis if necessary, therefore there is **No Guarantee that semen will be available for any specific day**. Semen orders will be requested by 5 pm MST the day prior to semen collection and canceled by 8 am MST the day of collection, it will be left to 88 Equine to determine if charges have incurred. All semen containers **MUST** be returned within 5 business days of receipt. If the container is not received within 5 business days the mare owner shall pay a NON-RETURN fee of \$50.00. All vapor shippers must be returned within 72 hours to the stallion collection agency or the mare owner will be charged an additional \$75.00 per day until the vapor shipper has returned.

a. The chute fee will cover one stallion collection, semen evaluation, and processing. If the Mare Owner requires the Stallion to be collected in more than one collection a fee of \$150.00 will be assessed for each additional collection.

b. Embryo Transfers: If more than 1 embryo is produced from Mare's breeding to Stallion and multiple embryos are transferred, Mare Owner shall notify Manager of the same within 48 hours of the transfer of embryos. If embryo transfers result in multiple pregnancies, Mare Owner shall pay the sum of the above Stallion fee to Manager for each additional pregnancy prior to issuance of any breeder's certificates

c. Breeding: Mare Owner is responsible for breeding Mare by artificial insemination and agrees to comply with all applicable rules and regulations concerning the use and handling of semen. Manager makes no warranty or guarantee, express or implied, with respect to the semen, including but not limited to the warranty of fitness for a particular purpose. Manager makes no guarantee of delivery within a certain time period and makes no guarantee that the semen will safely reach the insemination point without losing integrity, quality, or characteristics

4. Limited Live Foal Guarantee: Stallion fee does entitle mare owner a Live Foal Guarantee. I am entitled to a "live foal" conceived from this breeding that will stand and nurse after foaling without assistance and live for (24) hours. If my mare is found to not be in foal, or delivers to a stillborn, I am allowed a Rebreed Contract as long as 88 Equine is notified within (30) days of discovering the mare is open or the foal is stillborn. With this notification there must be a statement from a licensed veterinarian. **A rebreed contract will apply to the following breeding season only, and the stallion fee will be nonrefundable.** Live Foal Guarantee will be null and void if the mare owner does not give ample opportunity to settle the mare. Stallion owners will also be released from Live Foal Guarantee if mare is sold without notifying the Stallion Owner and providing the new owners contact information. 88 Equine has the option to require that the mare be brought on-site for re-breeding. *Second year re-breeds will be at the discretion of 88 Equine in conjunction with the Stallion Owner; additional breeding fees may apply.* Any re-breeding of Mare to Stallion will be subject to the payment of a \$500.00 chute fee and respective shipping fees (\$450.00 Priority Overnight). If Mare Owner fails to exercise the right to rebreed Mare in the immediately subsequent breeding season. Mare Owner's right to rebreed will be canceled.

5. Mare Substitutions: It is also agreed that if the mare dies before producing a live foal or becomes unfit to breed before being pronounced safe in foal, a substitute mare will be allowed for the current breeding season or the following season only. No Stud Fee will be refunded. In case the stallion becomes unserviceable for whatever reason, Stallion owner will utilize frozen semen if available to satisfy the contract for (1) year following the season the stallion is deemed to be unserviceable.

6. Vaccinations: Mare Owner warrants that the Mare is free of all communicable diseases upon arrival at the Ranch. On or prior to arrival, Mare Owner shall provide a record of the Mare's current vaccinations and a negative Coggins test performed within 6 months prior to arrival. If mare arrives without any of the required records, Manager may decline acceptance of Mare or provide the vaccinations and tests to Mare at Mare Owner's expense.

7. Cultures: Mare owner agrees that if they do not have a successful pregnancy after the first shipment, then 88 Equine reserves the right to require a clean culture before shipping semen again.

8. Breeders Certificate: A breeder's certificate will be issued to Mare Owner only after all expenses have been paid in full and upon notification of birth of foal.

9. Waiver of Liability: It is understood that the breeding farm, its owners, employees, and guests shall not be liable for any injury, escape, disability, or death of any horse on its premises. The above named Mare Owner, whose horse(s) is (are) under the care of Manager, will not be liable or responsible for any damage, injury or death to the breeding farm stallions, employees, veterinarians, or other animals in the care of Manager, whether or not caused by his/her horse.

10. State of Wyoming: This contract shall be governed by the laws of the State of Wyoming and venue in Johnson County, Wyoming. All accounts are due and payable in Johnson County, Wy in U.S. dollars.

11. This contract is not valid unless completed in full. When the Mare Owner signs and returns the contract and booking feed to the Manager, Manager will notify the Mare Owner within 10 days of approval. Upon notification, it will become a binding contract on both parties, subject to the above terms and conditions.
