These prices are effective as of November 1, 2025, but thereafter are subject to change without notice.

ITEMIZED SELECTIONS

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. Please note that our charges for direct cremation or direct burial, which do not require embalming, are predicated upon completion within a 36-hour period following state permit approval and include only those items and services indicated. This price list does not include prices for certain items that you may ask us to buy for you, such as cemetery property or merchandise, flowers, public transportation costs or paid newspaper notices. The prices for those items will be shown on your bill or the statement describing the merchandise and services you selected.

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF..... **\$950.00**

Our fee for our services and overhead will be added to the total cost of the arrangements you select. (This fee is already included in our charges for direct cremation, immediate burial, and forwarding or receiving of remains.) This fee includes but is not limited to: staff to respond to initial request for services; arrangement conference with family or responsible party; arrangement of funeral or cremation; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice; staff assistance prior to, during and immediately following the funeral, including coordination with those providing other portions of the funeral, e.g. cemetery, crematory and others. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses.

EMBALMING..... \$475.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. When embalming is not authorized, American Memorial reserves the right to regulate the time, place, and manner of any attendant ceremony and the maximum time period that the remains can be held before final disposition.

FORWARDING REMAINS TO ANOTHER FUNERAL FIRM \$1,295.00

This charge includes removal of remains from care facility during normal business hours, necessary services of staff, standard embalming, necessary authorizations, and local transportation to airport. This charge does not include viewing, visitation, religious rites, or ceremonies prior to forwarding of the body, autopsy repair, reconstruction, death certificate, or public transportation costs.

IMMEDIATE BURIALS \$9,295.00 to \$985.00 *

Our charge for immediate burial without any attendant rites or ceremonies includes removal of deceased from a care facility during normal business hours within 25 miles of our facility, shelter of remains (72hours), local transportation to cemetery, and necessary services of staff.

Our charge for direct cremation without any attendant rites or ceremonies includes removal of deceased from a care facility during normal business hours within a 25 miles radius of our facilities, local transportation to crematory and necessary services of staff. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we can provide are cardboard containers. The options we provide are:

- A. Direct cremation with container & urn provided by purchaser (Pre Arranged)..... \$695.00
- B. Direct cremation with container provided by purchaser & plastic urn..... \$722.00
- C. Direct cremation with alternative minimum container & plastic urn \$797.00

Funeral and cremation arrangements are completed in accordance with Washington State law (RCW 68.50.160). Absent required authorizations for cremation which requires due diligence (skip tracing) will result in a charge to the responsible party of \$185 per required authorization.
