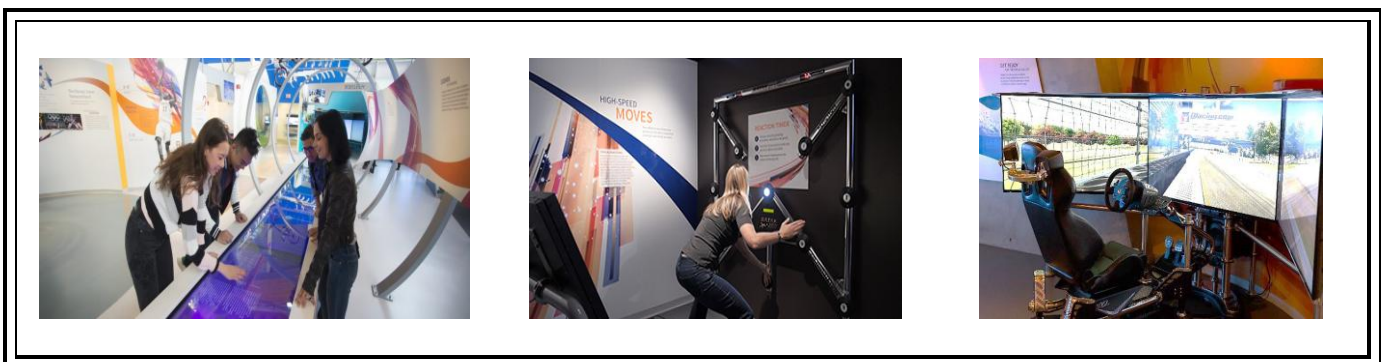
The Welcome Reception is an opportunity to connect with new and familiar colleagues. Light appetizers and refreshments will be provided.

Closed Meetings (or to those non-Corporate Officers “in-camera” meetings) continue to present some of the most challenging and sensitive situations for Corporate Officers. This session will explore the practical nuances of closed meetings and appropriate responses to issues that arise when Corporate Officers are excluded from discussions while still retaining key governance responsibilities.

Participants will examine scenarios and best practices for addressing situations such as certifying meeting minutes for sessions they were not permitted to attend, managing the addition of open or closed items after a meeting has already moved into a closed session, and responding appropriately when matters not included on the agenda are raised for information or discussion during a closed meeting.

Through discussion and practical examples, attendees will gain greater confidence in navigating these complex situations, maintaining procedural integrity, and balancing their statutory responsibilities with the governance needs of their organization.
