#### **MODULE 3: Understanding Accessibility**

This module explores accessibility and examines universal design through a local government example.

##### Learning outcomes:

- Define disability and ableism
- Recognize accessibility theories and models
- Understand universal design principles for greater inclusion

##### Assignments:

- Read an article, watch videos, and complete quizzes to deepen your understanding of concepts

Estimated time to complete the module and assignments is 90 minutes

#### **MODULE 4: Comprehending and Applying IDEA Practices**

This module explores unconscious bias, the relationship between intention and impact, effective bystander intervention, and the presence of embedded supremacy within workplace structures.

##### Learning Outcomes:

- Explore unconscious bias, intention, impact, and actions for effective intervention
- Recognize characteristics of white supremacy

##### Assignments:

- Complete activities and quizzes to deepen your understanding of concepts

Estimated time to complete the module and assignments is 90 minutes

#### **MODULE 5: IDEA in Local Government**

This module explores power, IDEA in local governments, and an exercise to put what you have learned into action.

##### Learning Outcomes:

- Explore types of power
- Identify and reflect on when to apply IDEA in local government to create inclusive policies or programs
- Establish commitments (personal and organizational)

##### Assignments:

- Review reference list, watch a video, complete self-reflection, and commit to activities to sustain learning and advocate for change
