## **Terms and Conditions**

PAYMENT, CANCELLATION & REFUND POLICY: A non-refundable deposit of \$750 is required to hold your reservation. Balance of payment is due 50 days prior to departure. Make check payable to Syversen Touring. If cancellation in writing is received more than 45 days prior to departure, a full refund less the \$750 deposit will apply. If cancellation in writing is received within 45 days of departure the deposit plus any amount that the airline, hotel & ground operator withhold are non-refundable. In case of cancellation due to pandemic or acts of terrorism, Syversen Touring reserves the right to retain a \$150 administrative fee.

**PRICES & ITINERARIES**: Prices are subject to increase based on severe currency fluctuations at the time of final payment. Once the airline tickets are issued they are fully non-refundable. Itineraries are prepared in advance and are subject to change. Activities are planned and scheduled according to the best information available at the time.

**BAGGAGE**: Each tour participant is permitted 1 large suitcase (maximum of 50 pounds) and 1 carry-on, plus a personal item (such as a purse or camera bag) due to the limited baggage area on the motorcoach.

DOCUMENTATION: All passengers must have passport that is valid at least six months from the return date. U.S. citizens do not need visas. However, health requirements are subject to change. As of this printing on June 11th, all testing and vaccination requirements have been lifted. In case of reinstatement which would prohibit you from participating in a tour, we recommend traveler's insurance. For citizens of other countries check with the consulate for entry documents and requirements.

**SINGLE OCCUPANCY**: Tour costs are based on double occupancy. Accommodation in a single room is available at an additional cost as specified on the tour application.

**TRAVELERS INSURANCE: Insurance is highly recommended.** We cannot accept any responsibility for loss or damage to property as a result of handling and/or accidents.

**COVID PROTOCOLS:** Some of the places we will be visiting may require face masks for those visiting their premises according to their state regulataions. In this case we would ask for your cooperation.

**MEALS**: As the meals offered during the tour are pre-arranged, we do not accommodate special dietary needs or restrictions.
