

**ORDINANCE NO. 422**

**AN ORDINANCE ESTABLISHING APPROVAL LIMITS FOR ENCUMBRANCE AND PAYMENT OF EXPENDITURES FOR THE CITY OF STILWELL AND REPEALING ALL OTHER ORDINANCES IN CONFLICT HEREWITH.**

**BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, STATE OF OKLAHOMA:**

**SECTION 1.** There are hereby established approval limits for encumbrance and payment of expenditures, subject to the limitations of law provided in Oklahoma Statutes Title 62, § 310.2, as hereinafter amended:

a. Encumbrance Clerk:	\$1,000.00
b. City Clerk-Treasurer:	\$2,500.00
c. Mayor:	\$2,500.00
d. Mayor & Clerk-Treasurer:	\$8,000.00

**SECTION 2.** Under no circumstances may multiple encumbrances and/or expenditures be made for the same purpose whose aggregate amount exceeds the approval limits above.

**SECTION 3.** Effective date of the above is hereby established effective the date such was approved as an agenda item at the regular meeting of the City Council on Monday, October 2, 2023.

**SECTION 4.** All ordinances and parts of ordinances in conflict herewith are hereby cancelled and repealed.


