c.	Mayor:	\$2,500.00
d.	Mayor & Clerk-Treasurer:	\$8,000.00

SECTION 2. Under no circumstances may multiple encumbrances and/or expenditures be made for the same purpose whose aggregate amount exceeds the approval limits above.

SECTION 3. Effective date of the above is hereby established effective the date such was approved as an agenda item at the regular meeting of the City Council on Monday, October 2, 2023.

SECTION 4. All ordinances and parts of ordinances in conflict herewith are hereby cancelled and repealed.
