### **ORDINANCE 438**

#### ORDINANCE TO ANNUL, DISCONTINUE AND CLOSE THE NORTH TO AN SOUTH ALLEYWAY IN BLOCK 3 OF THE ORIGINAL TOWN OF STILWELL, **OKLAHOMA**

WHEREAS, The City of Stilwell has authority to close streets and/or alleyways when closure does not adversely impact the land, the citizens who use them or any business which may be affected; and

WHEREAS, The City of Stilwell considers any request made to close streets and/or alleyways which may create a positive outcome or improve transportation or improve commerce, trade or economic development; and

WHEREAS, The City of Stilwell has received a request from the property owners of the property adjoining all sides of the alleyway to be so affected to officially annul, discontinue and close said alleyway;

## THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STILWELL:

#### SECTION 1: ENACTMENT

The following public way and/or easement in The City of Stilwell, Oklahoma, shall be and the same is hereby closed to the public use, to wit:

The north-south alleyway located between Second Street and Third Street north of Ash Street being contained within Block #3 of the Original Town of Stilwell.

#### **SECTION 2: RESERVATION OF RIGHTS**

That all rights of The City or any public or quasi-public corporation with reference to any public or quasipublic works or utilities are hereby expressly reserved and the above closing shall in no way impair the right to erect, construct, or repair poles, pipes, wires, conduits, or sewers and the purpose of such construction or repair of a perpetual easement under and over the above described public way or easement is hereby expressly reserved and, when in the opinion of the Council it shall be necessary, the same may be re-opened without expense to the City. In the event any excavation or fill is made therein all public utilities and equipment incident thereto shall be raised or otherwise protected so that no seepage into such public utilities shall occur by reason of the use made of the above closed public way or easement and that no impairment of the use of public utilities shall be caused by reason of such use. Any damage caused to such public utilities as aforesaid shall be borne by the person, firm, or corporation making use of the above closed public way or easement.

#### SECTION 3: REPEAL AND SEVERABILITY

- 1. Any and all other existing ordinances or portions thereof in conflict herewith be and the same are hereby repealed.
- 2. The provisions of this ordinance shall be severable and, if any of the provisions shall be held in contravention of the Constitution and laws of the State of Oklahoma, the decisions of the court shall not affect the validity of the remaining portions.
