

SUMMARY ANNUAL REPORT

For Travis Credit Union Medical, Dental, Vision Life and LTD

This is a summary of the annual report of the Travis Credit Union Medical, Dental, Vision Life and LTD, EIN 94-1242831, Plan No. 502, for period January 1, 2025 through December 31, 2025. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan, Unum Life Insurance Company Of America, Unum Life Insurance Company Of America and Vision Service Plan to pay health, vision, life insurance, temporary disability, long-term disability, prescription drug, HMO, ADD, EAP included and AD&D claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2025 were \$7,702,364.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (Travis Credit Union, One Travis Way, Vacaville, CA 95687) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs. Paperwork Reduction Act Statement
