# COTTER CITY COTTER COUNCIL MINUTES April 25, 2024 6:00 p.m. COUNCIL CHAMBERS

The regular meeting of the Cotter City Council was called to order at 6:00 p.m. by Mayor Caradine. He asked for roll call by Recorder/Treasurer Andrea Kray. Present were: Council Members Chuck Sugg, Shelia Wingard, Mertice Kray, Ben Woodard, and Linda McCarthy. Absent was: Carolyn Gill

### **REPORTS**

Approval of the March 28, 2024, regular minutes was the first item of business. Councilwoman Shelia Wingard moved to accept the minutes as presented from Recorder/Treasurer Andrea Kray with a second provided by Councilman Chuck Sugg. **Motion passed unanimously with Councilman Ben Woodard abstaining.**

### **UNFINISHED BUSINESS**

In the first order of Old Business, Council considered placing Ordinance 2024-01 on its 2nd reading. Councilwoman Mertice Kray moved to place Ordinance 2024-01 on its 2nd reading by title only with a second provided by Councilwoman Linda McCarthy. **Motion passed unanimously.** Recorder/Treasurer Andrea Kray read Ordinance 2024-01 by title only. It will be placed on the May 2024 Agenda for its 3rd and final reading.

### **NEW BUSINESS**

In the first order of New Business, Council was presented a check in the amount of \$4,413.60 by Annette Thrasher, Secretary of the Cotter Saturday Club from their Perpetual Care Fund. These funds are designated for maintaining the Walnut Hill Cemetery.

In the second order of New Business, Council considered renewing the Waste Connections contract for the City's waste disposal. Council was addressed by Kendrick Ketchum. The current rate is \$12.61 and will increase to \$16.50 as of June 2024. These contract renewal is for 5 years which includes no service on Thanksgiving, Christmas, and New Year's Day. Councilwoman Mertice Kray moved to renew the Waste Connections contract with a second provided by Councilwoman Linda McCarthy. **Motion passed unanimously.** 

In the third order of New Business, Mayor Caradine asked to postpone the consideration of Ordinance 2024-02 until the May Council meeting.

In the fourth order of New Business, Council considered scheduling a workshop for May 16, 2024, at 6:00 p.m. Councilman Chuck Sugg moved to set a workshop for May 16, 2024, at 6:00 p.m. with a second provided by Councilwoman Shelia Wingard. **Motion passed unanimously.** 

In the fifth order of New Business, Mayor Caradine presented Council with an update on the current pending City grants.

During information, Mayor Caradine shared the Cotter Trout Festival is set for Saturday, May 4, 2024. He also shared that the F3T Fly Fishing Film Tour is May 25, 2024, and that the Cotter Fly Casting Contest is set for May 25, 2024.
