August 25, 2022 -- 6:00 p.m.

The regular meeting of the Cotter City Council was called to order at 6:00 p.m. by Mayor Caradine. He asked for roll call by Recorder/Treasurer Andrea Kray. Present were: Council Members Chuck Sugg, Carolyn Gill, Cameron Ross, Mertice Kray, Linda McCarthy, and Mark Johnson.

The invocation was given by Councilman Cameron Ross followed by the recitation of the Pledge of Allegiance by all present.

REPORTS

Approval of the July 28, 2022, regular minutes was the first item of business. Councilwoman Mertice Kray moved to accept the minutes with noted corrections from Recorder/Treasurer Andrea Kray with a second provided by Councilman Chuck Sugg. Motion passed unanimously.

UNFINISHED BUSINESS

NEW BUSINESS

In the first order of New Business, Council considered Resolution 2022-13 - A Resolution to correct incorrect deposit account by DF&A received for the Police Stipend. The sender of the funds coded and directly deposited the funds to the incorrect account. This resolution provides a correction to place those funds their proper account. Councilwoman Mertice Kray moves to pass Resolution 2022-13 - A Resolution to correct incorrect deposit account by DF&A received for the Police Stipend with a second provided by Councilwoman Linda McCarthy. Motion passed unanimously.

In the second order of New Business, Council considered Resolution 2022-14 - A Resolution to set Baxter County Property Tax Levy (Mills) for Cotter to be accessed in 2022 to be collected in 2023. Councilman Mark Johnson moved to pass Resolution 2022-14 - A Resolution to set Baxter County Property Tax Levy (Mills) for Cotter to be accessed in 2022 to be collected in 2023 with a second provided by Councilman Chuck Sugg. Motion passed unanimously.

In the third order of New Business, Council considered Resolution 2022-15 – A Resolution to apply for Urban & Community Forestry Grant to Trim Trees in Big Spring Park and Warrior Park. Councilwoman Carolyn Gill asked if the City considered doing the older tress first. Mayor Caradine confirmed that the planning had not focused on the oldest trees first, but that if there were extra funds, other trees could be added. Councilman Cameron Ross moved to pass Resolution 2022-15 - A Resolution to apply for Urban & Community Forestry Grant to Trim Trees in Big Spring Park and Warrior Park with a second provided by Councilwoman Mertice Kray. Motion passed unanimously.

In the fourth order of New Business, Council considered Resolution 2022-16 - A Resolution for Loan and Grant from USDA for funding the Phase II Sewer Line Rehabilitation Project. Mayor Caradine provided an indepth update on the progress/status of the project. He covered concerns pertaining to manholes, easements, and meetings with land owners, engineers, and our city attorney. The Mayor along with Schuyler Brower and Neal Hodges met to discuss the current loan resolution ensuring that the letter of conditions is being followed. Mayor Caradine then asked Schuyler Brower to expand on the topic. The 1% sales tax renewal is in place to help with financing the cost of the project. If the project goes over budget, there is a possibility of increasing the loan and both mayors, the Cotter/Gassville commission chair are constantly looking, addressing, and working on the project. They hope to be breaking ground on these much needed repairs next year. There is a debt service/asset reserve requirement of 1 years' worth of payments for emergency and by the time the project starts the City of Cotter will almost have their share of the debt service/asset reserve in place.

Councilwoman Carolyn Gill asks if we get bids back and its higher, does the City have to repeat the entire process again. Mayor Caradine states he does not have an answer for that question at this time. Councilwoman Mertice Kray questions the inner city agreement. Does this loan application effect the current agreement? Mayor Caradine states that it does not.

Councilman Chuck Sugg moves to pass Resolution 2022-16 – A Resolution for Loan and Grant from USDA for funding the Phase II Sewer Line Rehabilitation Project with a second provided by Councilwoman Mertice Kray. **Motion passed unanimously with 6 yeas and o nays.**

INFORMATION

During information, Mayor Caradine shared the Cotter-Gassville Sewer Commission a letter to Arkansas Natural Resource Commission requesting financial consideration for Phase II Sewer Line Rehabilitation Project from the state ARPA American Rescue Program Act funds when available. He also encouraged Residents in the City of Cotter to fill our Survey received for Northwest Arkansas Economic Development District to be eligible for Grants. He explained the requirements of the Council obtaining 8 hours of Retail Water Provider Board Training for Act 605 of 2021. He advertised the Free Classic Movie in the Park on Saturday September 10, 2022 and October 8, 2022 at 8:30 in Big Spring Park under the Bridge. He also announced the Cotter Volunteer Fire Department and Auxiliary there annual fundraiser Chili and Silent Auction will be held on Saturday, November 12th and Garage Sale on November 11th & 12th.
