The regular meeting of the Cotter City Council was called to order at 6:00 p.m. by Mayor Caradine. He asked for roll call by Recorder/Treasurer Andrea Kray. Present were: Council Members Chuck Sugg, Kerry Ann White, Carolyn Gill, Mertice Kray, Cameron Ross, and John Bell.

NEW BUSINESS

In the first order of New Business, Jake Anderson addressed Council pertaining to the Arkansas Ultra Running Championship Event to take place over a 24 to 48-time period in the Big Spring Park in May 2020. This would be a qualifying event for the National Championship in Tennessee. It would bring commerce to our area and if all went well, this could become a yearly event. Jake Anderson and his team of volunteers would be providing the timing equipment, course markings as well as 1st aid and medical staffing. Councilwoman Kerry Ann White questioned the entry fee and Councilwoman Carolyn Gill questioned a temporary suspension of our current Park Ordinance pertaining to closing times. Hearing no objections from the Council, Jake Anderson will enter into further conversations with Mayor Caradine to decide on a date and other logistics of the event.

In the second order of New Business, Council considered Resolution 2019-20: A Resolution to adopt the 2020 Operating Budget. During information, Mayor Caradine informed Council that Ordinances 2019-04, 2019-05, & 2019-06 would go into effect on December 21, 2019. Recorder/Treasurer Andrea Kray read the 2019-2 Semi Annual Inventory in the minutes as well as read the Telephone Building items to be disposed of. Mayor Caradine shared that Cotter was approved by Governor Asa Hutchinson to receive a \$50,000 grant from the Department of Parks and Tourism for handicap parking and convert old tennis courts to multi-use courts. He also updated Council on Phase II Sewer Rehabilitation Project. The Public Works department installed a picnic table donated by Paul Stone for The Stone Family Children's Park on Combs Ave. The City Offices will be closed on December 24-25 & 31, 2019 and January 1, 2020. Mayor Caradine announced a vacancy on the Planning and Zoning - Mertice Kray's five-year term ends December 31, 2019. Any interested citizens may contact Mayor Caradine for more information. Christmas in Cotter with Santa and Mrs. Claus in Big Spring Park will be held on December 21, 2019 at 5:00 pm. The City of Cotter provided refreshments and cookies following the meeting.
