#### **NEW BUSINESS**

In the first order of New Business, Mayor Caradine recognized Ben Woodward and asked him to introduce himself to Council. In the fourth order of New Business, Mayor Caradine had the low bid from Aaron Lewis in the amount of \$44,308.00 for the concrete work for the Fun Grant for the NAYC read into the minutes and asked Council to consider entering into a contract with Aaron Lewis. Councilwoman Caroyln Gill asked for clarification on the project improvements and steps involved in the construction process. Councilwoman Mertice Kray moved to enter into a contract with Aaron Lewis for concrete work at the NAYC with a second provided by Councilman Cameron Ross. **Motion passed unanimously.**
