NEW BUSINESS

In the first order of New Business, Council considered Ordinance 2025-02 — Ordering Removal and Clean-up the House and Improvements at 427 McLean Ave. Mayor Caradine shared the City's history of the property. He then asked the City's Attorney, Roger Morgan, to address Council. Roger Morgan explained that there are two ways a city could take in the cleanup of unsightly properties. One way is to issue citations, bring them to court, and have the property owner pay fines. This way depends on the willingness of said property owner. The second way is to file an ordinance to go to court and have the city clean up or tear down placing a lein against the property for repayment.

Roger Morgan feels the second option is the best procedure for the City to take for progress to be made in cleaning up properties as plenty of notice is given.

Councilwoman Carolyn Gil asked is this occupant going to pleas hardship? His mother lives next door. The occupant goes there for water. The place could be considered a hoarding situation.

Councilwoman Linda McCarthy asks about the cars on the property and who decides if it needs to be razed?

Councilwoman Mertice Kray asks Roger Morgan for a timeline to the second procedure. He explains that after the complaint is filed, a summons issued, and serving the occupant, the occupant will have 30 days to respond. During Information, Mayor shared that the Sewer Project Phase IIB – Ryan Road Sewer line replacement will start by August 1st. The FEMA grant for new Fire Truck is still under review and decision want be available until the fall. The "Coffee with the Mayor" will be on Friday, July 25, 2025, at Cotter City Hall from 8 am to 9 am. Mayor shared that water damage on the roof of the NAYC in the amount of \$11,000 with a deductible of \$7,500. NAYC can pay the deductible and have contracted Paragon Roofing to replace the asphalt shingles. Cotter Public Schools will be resuming classes on Wednesday, August 13, 2025. Please be aware of increased traffic at the intersection of Hwy 62 and 62B.
