The center is awaiting a grant response on the roof as the historical designation causes issues. There is a new director, Calli Dilbeck. She is being trained by a former director.

## **INFORMATION**

During Information, Mayor shared that three CPA Firms responded to RFP request per Resolution 2025-05 to perform a single audit of the City's federal fund for the year ending December 31, 2024. The firm Hubbs & Whitehead, CPA of Van Buren, Arkansas, was selected. He read into the Meeting Minutes that the 2024 Financial Statement for all departments was presented to City Council and shall be posted at City Hall and the Post office on March 28, 2025, for 30 days at City Hall, Cotter Post Office and shall be posted on the City website as well as read into meeting minutes 2024 Semi-Annual Inventory changes. The Cotter Fire Department Chili and Fundraiser was a success. Thanks to the CVFD Volunteers and Auxiliary. The Cotter Warrior Foundation 5K Run in Big Spring Park on April 5, 2025. The race will be on the Walking Trail. Start time is between 7:00-7:30 am. The Cotter City Wide Yard Sale is scheduled for March 28-29, with the Large Item Pickup scheduled for the following Monday, March 31. The Annual Cotter Trout Festival is Saturday, May 3, 2025. The F3T Flyfishing Film Tour movie and fly-casting contest will be held on May 24, 2025. The "Coffee with the Mayor" dates have changed to the last Friday of each month. The next meeting will be on February 28th at the Commercial Hotel at 110 McLean Ave, Cotter, Arkansas, from 8 am to 9 am.

Jason Nazarenko asked Council to consider reviewing policies pertaining to area beautification. There are some areas of concern as there are items around the city out of compliance. Those items are unlicensed cars and abandoned houses/trailers that are safety concerns. He stated a new bill 1695 passed in the House. It is going to Senate next pertaining to liens on property that is unsightly and unsafe. Mayor Caradine asked Jason to address another proposed bill pertaining to property rights and the current authority of the Cities' P & Z Commissions.

### COUNCIL COMMENTS

Councilwoman Ang Pereira thanks everyone and stated moving here has been wonderful. She announced a work session set for 1:00 pm on March 28, 2025, in the Walnut Hill Cemetery to do an assessment of graves. She had two flags that will go in the cemetery and Mayor Caradine said he'd purchased more as well.

Councilwoman Linda McCarthy had noticed some youth cleaning in the park, and it was shared that it was Juvenile Service Week.

Mayor Caradine gave an update on the pump project and asked citizens to let him know if there were pressure issues they've noticed. Both Freddie Wooten and Sharen Kaster confirmed pressure issues at the Firehouse. Lights are finished in the park and a new unveiling of the Cotter branding will be released at the end of April.

Councilwoman Mertice Kray moved to adjourn with a second provided by Councilwoman Ang Pereira. **Motion passed unanimously.** Meeting ended at 7:50 p.m.
