The regular meeting of the Cotter City Council was called to order at 6:00 p.m. by Mayor Caradine. He asked for roll call by Recorder/Treasurer Andrea Kray. Present were: Council Members Chuck Sugg, Carolyn Gill, Cameron Ross, Mertice Kray, Linda McCarthy, and Mark Johnson.

The invocation was given by Councilman Cameron Ross followed by the recitation of the Pledge of Allegiance by all present.

## **REPORTS**

Approval of the April 28, 2022, regular minutes was the first item of business. Councilwoman Linda McCarthy moved to accept the minutes as written from Recorder/Treasurer Andrea Kray with a second provided by Councilman Cameron Ross. **Motion passed unanimously.**

# **UNFINISHED BUSINESS**

# **NEW BUSINESS**

In the first order of New Business, Paul Shuttleworth with Waste Connections request that the City of Cotter for a Fuel Cost Rate Adjustment allowed per the current contract for waste disposal. The rate will revert back to the current rate once fuel goes back down below \$4.25 for a minimum of 30 days. It was also stated that Cotter is still the lowest rate in the local area. Councilwoman Mertice Kray moves to agree to the rate increase as stated in the current contract with a second provided by Councilwoman Carolyn Gill. **Motion passed unanimously.** 

In the second order of New Business, Council considered Resolution 2022-10: A Resolution to amend the 2022 Operating Budget for the Waterworks Revenue Fund for emergency repairs at Hwy 62/412 to replace the water pump and electric motor. Councilman Chuck Sugg moves to pass Resolution 2022-10: A Resolution to amend the 2022 Operating Budget for the Waterworks Revenue Fund for emergency repairs at Hwy 62/412 to replace the water pump and electric motor with a second provided by Councilman Mark Johnson. **Motion passed unanimously.** 

In the third order of New Business, Council considered Ordinance 2022-06: An Ordinance amending the City of Cotter Municipal Code 4.28 by replacing the existing alcohol Ord. 79-7 to regulate alcoholic beverages to comply with the state of Arkansas Title 3. During the reading of the Ordinance it was discovered that critical passages where left out of the Ordinance as a previous draft was presented instead of the most recent draft. Councilwoman Mertice Kray moved to call for a 5 minute recess, so that the proper draft could be printed and thus presented with a second provided by Councilman Chuck Sugg. **Motion passed unanimously.** 

Mayor Caradine recessed from 6:32 p.m. and reconvened that 6:37 p.m.

Councilwoman Mertice Kray then moved to pass Ordinance 2022-06: An Ordinance amending the City of Cotter Municipal Code 4.28 by replacing the existing alcohol Ord. 79-7 to regulate alcoholic beverages to comply with the state of Arkansas Title 3 as an emergency with a second provided by Councilman Chuck Sugg. **Motion passed unanimously.** 

Councilman Chuck Sugg moved to pass Ordinance 2022-06: An Ordinance amending the City of Cotter Municipal Code 4.28 by replacing the existing alcohol Ord. 79-7 to regulate alcoholic beverages to comply with the state of Arkansas Title 3 with a second provided Councilwoman Carolyn Gill. **Motion passed unanimously.** 

In the fourth order of New Business, Council considered Resolution 2022-09: A Resolution to amend the operation budget to receive insurance money to replace a police vehicle. Recorder/Treasurer Andrea Kray read the resolution in its entirety. Chief Travis Hopson explained the details of the replacement and location of the replacement vehicle would be out of Chicago. Councilwoman Carolyn Gill moved to pass Resolution 2022-09: A Resolution to amend the operation budget to receive insurance money to replace a police vehicle with a second provided by Councilman Chuck Sugg. **Motion passed unanimously.** 

#### **INFORMATION**

During information, Mayor Caradine shared that Cotter's State Aid paving project will start in June and at this time Section Line Road will not be paved as residential construction is taking place and that street will need to be paved once construction is complete. Mayor Caradine also shared that the City of Cotter is in the path of the Great north American Eclipse occurring on Apr. 8, 2024. He also shared that the FT3 Fly Fishing Film Tour is scheduled for May 28, 2022.
