The regular meeting of the Cotter City Council was called to order at 6:00 p.m. by Mayor Caradine. He asked for roll call by Recorder/Treasurer Andrea Kray. The invocation was given by Councilman Cameron Ross followed by the recitation of the Pledge of Allegiance by all present.

REPORTS

Approval of the October 24, 2019, regular minutes was the first item of business. Councilman John Bell moved to accept the minutes as written from Recorder/Treasurer Andrea Kray with a second provided by Councilman Chuck Sugg. **Motion passed unanimously.**

UNFINISHED BUSINESS

In the sixth order of Unfinished Business, Council then considered passage of Ordinance No 2019-06: An Ordinance amending Ordinance No 2004-06 regulating the use and sale of fireworks with a motion by Councilman John Bell and a 2nd provided by Councilman Cameron Ross. **Motion passed unanimously.**

NEW BUSINESS

In the first order of New Business, Brian Haas, CPA, presented Council with findings for the Municipal Wastewater Audit. No critical findings in the audit. The budget is managed well, and he will consult with the city's attorney to confirm no existing lawsuits prior to his releasing the report. He compliments Melissa Gray on her management as she stops issues before they ever get to him. He states that the water loss can cause problems, but Justin Morrow and his crew do a good job of replacing systems when they appear, and he suggest keeping the well. One change he noted for future years was internal control over financial statement preparation and review. Starting in 2020, Mr. Haas will no longer be able to verify our bookkeeper's disclosure checklist establishing internal control over the financial statements preparation and review.

In the second order of New Business, Mayor Caradine stated that one application had been submitted to fill the vacated Ward 1 Position 1 seat by Mrs. Carolyn Gill. Mayor Caradine asked for a nomination recommendation. Councilman Chuck Sugg moved to appoint Carolyn Gill to fill the vacant Ward 1 Position 1 seat with a second provided by Councilwoman Kerry Ann White. **Motion passed unanimously.** Mayor Caradine then installed/swore Carolyn Gill into office with her term ending December 31, 2020.

In the third order of New Business, Mayor Caradine presented Council with the AR Municipal League Death and Dismemberment plan. There was no motion to consider purchasing this insurance.

In the fourth order of New Business, Mayor Caradine presented the Northwest Arkansas Economic Development District partnership agreement for the 2020 Calendar Year. Councilman Cameron Ross moved to continue the partnership with the NWAEDD at a cost of \$110.00 to be added to the 2020 budget with a second provided by Councilwoman Mertice Kray. **Motion passed unanimously.**

In the fifth order of New Business, Councilman John Bell moved to approve an extra payment of \$7,967.00 be made to the ANRC loan for Phase I of the Ductile Iron repairs with a second provided by Councilman Cameron Ross. **Motion passed with 5 in Favor and Councilwoman Mertice Kray opposed.** This will be the 2nd extra payment made this year.

During information, Mayor Caradine asked Council to review the 2020 Budget before the workshop on November 25, 2019 at 7:00 pm. The Cotter Sewer Expense for 2020: 36% Cotter and 64% Gassville, and the next Council Meeting will be on Thursday, December 18th at 6:00 pm. The White River Marathon will be held on Saturday November 23, 2019, and Christmas in Cotter Tour of Lights will be on December 1-January 2, 2020. Santa and Mrs. Claus will be in the Big Spring Park, December 21, 2019 5:00 pm. Waste Connections

will be using the side cart loader starting the 1st week in January. There will be a free cart for all water accounts and the cart comes with instructions. A 2nd can is available for \$48 per year. The City of Cotter provided refreshments and cookies after the meeting.
