

ORDINANCE NO. 133-A (1979)

An ordinance amending City of Cotter, Arkansas, Ordinance No. 133 entitled "AN ORDINANCE REGULATING THE INSTALLATION, ALTERATION, AND MAINTENANCE OF ALL PIPING EXTENDING FROM THE POINT OF DELIVERY OF GAS FOR USE AS A FUEL AND DESIGNED TO CONVEY OR CARRY THE SAME TO GAS APPLIANCES, AND REGULATING THE INSTALLATION AND MAINTENANCE OF APPLIANCES DESIGNED TO UTILIZE SUCH AS GAS AS A FUEL. WITHIN THE CORPORATE LIMITS OF THE CITY OF COTTER ARKANSAS; PROVIDING FOR THE INSPECTION OF SAID PIPING AND INSTALLATION OF SAID PIPING AND CERTAIN APPLIANCES AND THE COLLECTION OF INSPECTION FEES THEREFORE; PROVIDING FOR THE LICENSING OF PERSONS ENGAGING IN THE BUSINESS OF INSTALLING, REPAIRING, OR MAINTAINING SAID PIPING OR CERTAIN APPLIANCES; PROVIDING PENALTIES FOR THE VIOLATION OF THIS ORDINANCE, AND REPEALING ALL CONFLICTING ORDINANCES.

WHEREAS, "CHAPTER 10. FEES" Ordinance No. 133 provides for inspection fees for inspection of various gas piping and installations and permits for such inspection: and

WHEREAS, the fees set forth therein are now inadequate to cover the cost of issuance of permits and the inspector's fee for making inspection:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COTTER, ARKANSAS AS FOLLOWS:

I. "CHAPTER 10. FEES" is hereby deleted from the aforesaid Ordinance No. 133.

II. In the place and stead of said deleted "CHAPTER 10. FEES", the following shall be inserted:

CHAPTER 10. FEES

(a) An inspection fee of \$5.00 shall be paid by the person requesting inspection for each gas inspection at the time request is made therefor, which fee shall include the issuance of permit for inspection.

(b) If installation does not pass inspection, after correction, for each re-inspection until installation meets approval of inspector the fee shall be \$5.00. No permit shall be required for re-inspection or re-inspections.

(c) Request for inspection shall be made at Cotter City Hall, Cotter, Arkansas, at least 48 hours prior to the time actual inspection is to be made. Payment of fee for inspection shall be made at the time of request and permit for inspection will be issued

at same time. Payment of fee for any re-inspection shall also be made at the Cotter City Hall but no permit shall be necessary for re-inspection.

(d) Not less than 24 hours prior to the time the actual inspection or re-inspection is to be made, the City of Cotter shall notify the Gas Inspector of the time and place of inspection and the name of the person requesting such inspection or re-inspection.

(e) From the aforesaid \$5.00 fee, the Gas Inspector shall receive \$3.00 for each inspection or re-inspection and the City of Cotter shall retain \$2.00.

III. Except for the aforesaid amendment of "CHAPTER 10. FEES" said Ordinance No. 133 shall remain in all other respects as passed.

IV. It is hereby ascertained and declared that there is an immediate need to amend Ordinance No. 133 with regard to inspection fees and permits and, such amendment being necessary for the preservation of the public peace, health, safety and welfare, this amendment to Ordinance No. 133 shall take effect and be in force from and after its passage as provided by law.
