AN ORDINANCE LEVYING COURT COSTS ON CASES BROUGHT BY THE CITY OF COTTER, ARKANSAS, IN THE CITY COURT OF COTTER, ARKANSAS AND/OR MUNICIPAL COURT OF THE CITY OF MOUNTAIN HOME, ARKANSAS, CREATING A CRIMINAL JUSTICE FUND, REVOKING ORDINANCE 7-1981, DECLARING AN EMERGENCY AND FOR OTHER PURPOSES.

WHEREAS, THE CITY OF COTTER, ARKANSAS, HERETOFORE PASSED ORDINANCE 7-1981, SETTING COURT COSTS AT \$3.00;

WHEREAS, THERE IS A GREAT NEED FOR ADDITIONAL REVENUES TO PAY THE COST OF KEEPING PRISONERS;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF COTTER, AR-KANSAS:

SECTION 1. UNDER AUTHORITY OF ACT 942 OF 1981, THERE IS HEREBY LEVIED AND SHALL BE COLLECTED FROM EACH DEFENDANT UPON PLEA OF GUILTY, NOLO CONTENDERE, FORFEITURE FO BOND OR DETERMINATION OF GUILT OF A MISDEMEANORS OR TRAFFIC VIOLATIONS IN THE MUNICIPAL COURT OF MOUNTIAN HOME, ARKANSAS, AND/OR THE CITY COURT OF COTTER, ARKANSAS, THE SUM OF FIVE (\$5.00) DOLLARS ON EACH SUCH CASE.

SECTION II. THE MONIES COLLECTED BY THE LEVY OF THIS \$5.00 COURT COSTS SHALL BE DEPOSITED IN A SEPERATE ACCOUNT KNOWN AS THE "CRIMINAL JUSTICE FUND" OF THE CITY OF COTTER, ARKANSAS AND SUCH MONIES SHALL BE USED SOLELY FOR REIMBURSING THE COUNTY FOR EXPENSES INCURRED IN INCARCERATING CITY OF COUTER PRISONERS.

SECTION III. COTTER ORDINANCE NO. 7-1981 IS HEREBY IN ALL RESPECTS REPEALED, CANCELLED AND REVOKED.

SECTION IV. THIS ORDINANCE BEING NECESSARY FOR THE WELFARE, SAFETY, AND PUBLIC PEACE OF THE INHABITANTS OF THE CITY OF COTTER, ARKANSAS, AN EMERGENCY IS DECLARED TO EXIST AND THIS ORDINANCE SHALL TAKE EFFECT IMMEDIATELY UPON ITS PASSAGE.
