ORDINANCE NO. 93-05

AN ORDINANCE HAVING FOR ITS PURPOSE FIXING THE SALARIES OF THE OFFICIALS OF COTTER, ARKANSAS, A CITY OF THE SECOND CLASS.

WHEREAS, the State Law provides that when the Town becomes a City of the Second Class, the town officials become the city officials of the City of the Second Class, to serve as such for the full period of time for which they were elected, or until their successors are elected and qualified.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COTTER, ARKANSAS;

SECTION 1. That the present officers of the Incorporated Town of Cotter shall be the officers of the City of Cotter until their successors are elected and qualified according to law.

SECTION 2. That the fees and salaries of the officers of the City of Cotter are as follows; effective $\bar{J}u1y$ 01, 1993

Mayor \$375.00 per month (\$4,500.00 YR) (\$1,390.003333 actual)

Recorder-Treasurer \$1,390.00 per month (\$16,680.04 YR)

Aldermen \$25

\$25.00 per meeting

SECTION 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. Whereas, it is necessary for the efficient administration of the municipal government of the City of Cotter that the city perfect itself as a City of the Second Class, therefore, an emergency is hereby declared to exist and this ordinance being necessary for the preservation of the public peace, health and safety this ordinance shall be in full force and effect from and after its passage and approval.
