ORDINANCE NUMBER 03-08

AN ORDINANCE RELATING TO THE ZONING REGULATIONS FOR THE CITY OF COTTER, ARKANSAS AS ESTABLISHED BY CITY ORDINANCE No. 158-7; AMENDING CHAPTER II, SECTION B, OF SAID ZONING REGULATIONS.

WHEREAS, It has been determined by the City Council of Cotter, Arkansas that there is not now any adequate provisions for dealing with a certain type of structure as defined in the existing zoning regulations; and

WHEREAS, Fences are designed to define and confine real property and as such, cannot be subjected to set-backs and other requirements of a structure as defined in The Zoning Regulations, Chapter II, Section B, Line 24.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COTTER, ARKANSAS:

SECTION 1: REGULATIONS. That Chapter II, Section B, Line 24 be amended to delete only the word; "fences", thereby freeing fences of the zoning requirements pertaining to other structures.

SECTION 2: Nothing in this Ordinance shall be construed to change, modify or nullify any existing ordinance, resolution or regulation pertaining to fences along or within prescribed utility easements.


