

A RESOLUTION APPROVING PIPELINE LICENSE WITH MISSOURI PACIFIC RAILROAD COMPANY AND ITS EXECUTION BY THE CITY OF COTTER, ARKANSAS.

WHEREAS, in constructing the Cotter-Gassville Sewer System, a pipe line, 15 inches in diameter, was laid by the contractor without permit or license and without consulting the City Attorney for conveying Cotter sewage on, along, across, and beneath the surface of right-of-way land, as well as crossing beneath track of the Missouri Pacific Railroad Company between Engineer's Chaining Stations 6485+90 (Mile 381.97) and 6491+75 (Mile 381.86), Section 6, Township 18 North, Range 14 West, at Cotter in Baxter County, Arkansas, commonly known as the "Third Street Crossing";

WHEREAS, said railroad recently and urgently requested that a Pipe Line Permit submitted by it be executed for such construction containing terms and conditions required by said company, this crossing being a main line sewer necessary for carrying sewage from the downtown area of Cotter to the treatment plant; and

WHEREAS, since said installation had been in place for a number of years and since, in any event, this necessary pipe line would have to cross along, over, and beneath the railroad right-of-way and track either at its present location or elsewhere, the City Attorney informed the Mayor and Recorder of the City of Cotter, Arkansas, that the Pipe Line License submitted by the railroad company should be executed;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COTTER, ARK.:

1. That the Pipe Line License with the Missouri Pacific Railroad Company, copy of which is attached hereto and made a part hereof as though set forth at length herein, be and it hereby is approved;
2. That the action of the Mayor and Recorder of the City of Cotter, Arkansas, in executing said Pipe Line License on behalf of the City be, and it hereby is, approved; and
3. That a copy of said License be recorded in the office of the Circuit Clerk and Ex-Officio Recorder of Baxter County, Arkansas.
