| A RESOLUTION AUTHORIZING THE NEGOTIATION, EXECUTION, AND DELIVERY OF A LEASE / PURCHASE AGREEMENT IN THE PRINCIPAL AMOUNT OF \$ 46,776,00 , BETWEEN CITY OF COTTER  |

| COUNTY, ARKANSAS , AND FIRST MUNICIPAL DIVISION - BANC ONE LEASING CORPORATION, DENVER, COLORADO; PROVIDING FOR TEN (10) ANNUAL LEASE PAYMENTS FROM   |
| LEGALLY AVAILABLE MUNICIPALITY FUNDS; AND PRESCRIBING OTHER DETAILS IN CONNECTION THEREWITH.  |
| WHEREAS, CITY OF COTTER (the "Municipality") is a   |
| duly organized and existing pursuant to the Constitution and laws of the State of Arkansas; and   |
| WHEREAS, pursuant to applicable law, theCITY_OF_COTTER  |
| WHEREAS, theCOUNCIL hereby finds and determines that the execution of an Agreement for the purpose of leasing with the option to purchase the equipment designated and set forth in Schedule A to the Lease/Purchase Agreement is appropriate and necessary to the function and operations of the Municipality; and   |
| WHEREAS, FIRST MUNICIPAL DIVISION - BANC ONE LEASING CORPORATION, Denver, Colorado (the "Lessor"), duly organized, existing, and in good standing under the laws of the State of Ohio, shall act as Lessor under said Lease/Purchase Agreement; and   |
| WHEREAS, the Lease/Purchase Agreement shall not constitute a general obligation indebtedness of the Municipality within the meaning of the Constitution and laws of the State; and  |
| NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE:  |
| Section 1. The <u>COUNCIL</u> and <u>MAYOR</u> acting on behalf of the Municipality, are hereby authorized to negotiate, enter into, execute, and deliver the Lease/Purchase Agreement in substantially the form set forth in the document presently before the <u>COUNCIL</u> , which document is available for public inspection at the office of the Municipality. The <u>MAYOR</u> and <u>CITY COUNCIL</u> acting on behalf of the Municipality, are hereby authorized to negotiate, enter into, execute, and deliver such other documents relating to the Lease/Purchase Agreement as the <u>MAYOR</u> and <u>CITY COUNCIL</u> , upon advice of counsel, deem necessary and appropriate. |
| Section 2. The Lease/Purchase Agreement shall be in the principal amount of \$46,776.00, bearing interest as set forth in Exhibit B of the Agreement; said Lease/Purchase Agreement to contain an option to purchase by the Municipality as therein set forth.  |
| Section 3. The Municipality's obligation under the Lease/Purchase Agreement shall be annually renewable by the Municipality and expressly subject to annual appropriation by the Board; and such obligation under the Lease/Purchase Agreement shall not constitute a general obligation of the Municipality or indebtedness within the meaning of the Constitution and laws of the State of <u>Arkansas</u> .  |
| Section 4. All other related contracts and agreements necessary and incidental to the Lease/Purchase Agreement are hereby authorized.   |
