The regular meeting of the Cotter City Council was called to order at 6:00 p.m. by Mayor Caradine. He asked for roll call by Recorder/Treasurer Andrea Kray. Present were: Council Members Chuck Sugg, Carolyn Gill, Cameron Ross, Mertice Kray, Linda McCarthy, and Mark Johnson.

The invocation was given by Councilman Cameron Ross followed by the recitation of the Pledge of Allegiance by all present.

REPORTS

Approval of the August 26, 2021, regular minutes was the first item of business. Councilman Chuck Sugg moved to accept the minutes as written from Recorder/Treasurer Andrea Kray with a second provided by Councilwoman Linda McCarthy. Motion passed with 5 in Favor and Councilman Mark Johnson abstaining due to not being in attendance at the August 2021 meeting.

UNFINISHED BUSINESS

In the first order of Unfinished Business, Mayor Caradine had Recorder/Treasurer Andrea Kray read Ordinance 2021-04 - An Ordinance amending the Municipal Code to add Chapter 8.24 - Recreational Vehicles for its 3rd reading by title only. Council then considered passage of Ordinance 2021-04 - An Ordinance amending the Municipal Code to add Chapter 8.24 - Recreational Vehicles. Councilman Chuck Sugg moved to pass Ordinance 2021-04 with the elimination of the 2nd sentence on page 2 under section "B Habitation" along with numbers 1-7 with a second provided by Councilman Cameron Ross. During discussion, Mayor Caradine asked Jason Nazarenko to provide a recap of the Ordinance as the P & Z Chair. **Motion passed unanimously.** The Ordinance will be posted in the 5 locations in Cotter and go into effect 30 days from passage.

NEW BUSINESS

In the first order of New Business, Rebekka Foster - CVFD Safety Officer/ Secretary – presented to Council a program for Community Emergency Response Team for Natural disasters. This CERT team provides basic response skills to citizens through classroom exercises. Train volunteers can then assist in with emergency response efforts during times like natural disasters. She provided examples of how CERT teams can benefit the community and the qualifications to volunteer. The Fire Department is seeking Council's approval to move forward with this project and Council verbally agrees.

In the second order of New Business, Mayor Caradine asked Recorder/Treasurer Andrea Kray to read Resolution 2021-17 - Consider Resolution to set Tax Levy (Mills) Assessed in 2021 to be collected in 2022 in its entirety. Councilman Chuck Sugg moved to pass Resolution 2021-17 - Consider Resolution to set Tax Levy (Mills) Assessed in 2021 to be collected in 2022 with a second provided by Councilman Cameron Ross. **Motion passed unanimously.**

In the third order of New Business, Mayor Caradine read into meeting minutes the acceptance of Engineering Service, Inc as recommended by NWAEDD to perform engineering services for the City of Cotter Water Rehabilitation Project for funds received from the American Rescue Act.

In the fourth order of New Business, Mayor Caradine asked Council to consider moving the November and December 2021 meeting up a week due to the holiday season. Councilman Cameron Ross moved to set the November 2021 meeting to 11/18 and the December 2021 meeting to 12/16 with a second provided by Councilwoman Carolyn Gill. **Motion passed unanimously.**

In the fifth order of New Business, Mayor Caradine asked Council to consider setting a Workshop in the month of November for the Budget Planning. Councilwoman Mertice Kray moved to set a Budget Workshop for 11/9/21 at 6:30 pm with a second provided by Councilman Mark Johnson. **Motion passed unanimously.**

During information, Mayor Caradine shared that the Cotter-Gassville Chamber of Commerce Movie in the Park will be held on October 8, 2021, 7:30 pm in Big Spring Park with hot dogs and popcorn.
