BODY OF PERSON EXEMPTION LICENCE

Leeds Children's Services on behalf of Leeds City Council, hereby grant 'Body of Person' status to Drighlington Events Committee for the performance of "Drigmass 2024" on Saturday 30th November 2024 at Drighlington Cricket Club, Station Road, Drighlington, BD11 1JU subject to the following criteria:

- The children must not have time off school for rehearsals or performances.
- No payment in respect of the child's taking part in the performance is made (whether to him or any other person).
- All current and new members of staff in the "body of persons" whether paid or unpaid, who have contact
 with the children, must have been DBS checked by the local authority where they live and the body must
 keep records of their checks for inspection.
- It is the responsibility of the 'Body' to ensure that people looking after children (who are not their parent/guardian) have been DBS checked by their local authority where they live and keep records of their registrations.
- The "Body" to ensure that for rehearsals and performances the ratio is no more than 12 children to one chaperone and that the children must be in the care of a chaperone at all times from arriving at the place of performance/rehearsal to leaving the place of performance/rehearsal.
- The 'Body' must not allow children to perform at any venue that has not been approved by Leeds Children's Services.
- The 'Body' must not permit children to be at the place of rehearsal/performance outside the hours permitted by The Children (Performances) Regulations 1968.
- The 'Body' to ensure that a schedule of forthcoming performances is submitted to Leeds Children's Services 14 days prior to each production.
- The 'Body' must keep records of each child's performance:
 - the date of performance/s
 - time of arrival and departure
 - name of Chaperone who is responsible for child
 - nominated first aider per performance
- It is the responsibility of the 'Body' to ensure that suitable arrangements have been made for the child to get to and from the venue where the performance/rehearsal is being held.
- The 'Body' must not use children in performances that may be dangerous or to train children for dangerous performances.
- It is the responsibility of the 'Body' to notify Leeds Childrens Services of any changes to the original application i.e. change of premises, chaperones etc.
- The organisation will have regard to Covid guidance issued by the government and review this at regular intervals. Should there be changes in Covid guidance and the event is delayed or cancelled the LA will be informed about any changes.
