CALL TO ORDER

President Gerald Wuetcher called the meeting to order at 5:00 p.m. It should be noted that Vice President Bill Shanks, Treasurer Patrick Hall, Maurice Bakke, Susan Buffin, and Stacy Thurman attended the meeting via Zoom pursuant to KRS 61.840.

GUESTS - MANDY FLYNN AND LISA DELONG

Mandy Flynn and Lisa Delong from Collective Spaces Interior Design Group shared their interior design plans for the local history room. They reiterated their intention to repurpose as much of the existing furniture as possible in the expansion project.

The Board will review and consider the proposal at the December meeting.

GUEST – TOM SMITH

Tom Smith reviewed his meeting with the Woodford County Board of Architectural Review. He informed the Board that the plan had been approved with the Board of Architectural Review requesting only a few minor revisions to the plan that can be accommodated easily.

The architectural plans will now be submitted to the Kentucky Department of Housing, Building and Construction.

Mr. Smith expects that the Library will be able to get a demolition permit within 1-2 weeks of submitting the application.

APPROVAL OF OCTOBER MINUTES - REGULAR BOARD MEETING - OCTOBER 21, 2020

President Wuetcher submitted a draft of the minutes from the regular meeting on September 21, 2020. The draft was changed to note that the motion to adjourn was approved by a vote of 3-0, not 5-0. Patrick Hall made a motion to approve the minutes as changed. Annie Denton seconded the motion. The Board approved the motion by a vote of 4-0.

A. Approval of Special Board Meeting Minutes – November 4, 2020

President Wuetcher submitted a draft of the minutes from the special meeting held on November 4, 2020. Bill Shanks made a motion to approve the minutes as submitted. Annie Denton seconded the motion. The Board approved the motion by a vote of 4-0.

FINANCIAL REPORT

Karen reports that the budget is on target. The Library has received the bulk of its tax revenue for fiscal year 2020-2021.

Annie Denton made a motion to accept the financial report and approve the payment vouchers. Bill Shanks seconded the motion. The Board approved the motion by a vote of 4-0.

FRIENDS OF THE LIBRARY REPORT

Maurice Bakke reports that the Friends currently have \$6,705.15 in its checking account. The Friends did not have a meeting this month. Mr. Bakke did inform the Board that they hope to have a golf scramble as a fundraiser in the coming year.

WOODFORD COUNTY HISTORICAL SOCIETY REPORT

The Historical Society will meet on November 19, 2020. Ballots to elect the Board of Directors have been mailed and emailed to members. The Board of Directors will determine if the Historical Society can remain open given the increase of COVID-19 cases in Woodford County.

VERSAILLES REPORT

Foot traffic to borrow materials and use computers has remained steady, though there has been an increase in the number of holds placed by patrons. The Library has also continued to augment its digital library and offer a wide-range of virtual programs.

MIDWAY REPORT

The ballots cast at the Midway Branch were collected for the 2020 general election and the ballot box removed. The placement of a ballot box at the Midway Branch was a huge success and greatly appreciated by residents. The Library would be willing to be a ballot box site in the future.

Stacy has been facilitating the "Writing for Healing, Hope, Justice, and Peace" programs. There were eleven participants last month and eighteen participants scheduled for this evening's program.

It is anticipated that Governor Andy Beshear will soon announce new restrictions on restaurants and public facing businesses. Karen and the Board discussed the possibility of returning to curbside service only, as COVID-19 cases continue to increase in the state and county.

Bill Shanks made a motion that the Library provide only curbside service, effective November 23, 2020 through December 13, 2020. Annie Denton seconded the motion. The Board approved the motion by a vote of 4-0.

President Wuetcher indicated that he would call a special board meeting the week of December 7th if warranted.
