### Qualification Structure:

To achieve the Focus Awards Level 4 Certificate in Chemical Skin Peeling Treatments (RQF) learners must complete the mandatory unit to achieve a total of 14 credits.

**There is one mandatory unit:** Providing Chemical Skin Peeling R/618/5345

1. Understand chemical skin peeling
2. Be able to plan for chemical skin peeling treatments
3. Be able to carry out chemical skin peeling treatments

### Additional Information:

**Ages Restrictions:** Age Ranges Entry is at the discretion of the centre however; learners should be 18+ to undertake this qualification.

**Prerequisite:** Learners must have achieved an anatomy and physiology qualification at a minimum of Level 2 Beauty therapy or a Level 2 qualification in skincare and facial treatments, core knowledge of facial anatomy. However other requirements may be required by the academy. (If you do not hold any of the above qualifications, these can be achieved through DynicaBeauty Academy).

**Geographical Coverage:** This qualification is available in England.

**Qualification Purpose:** The aim of Level 4 Certificate in Dermaplaning Treatments (RQF) QRN: 603/5587/6 is to provide learners with the knowledge and skills required to safely plan and provide Dermaplaning treatments to clients.

**Qualification type:** Practical observations and theory assignments

**Assessment Methods:** This qualification is internally assessed, internally and externally quality assurance assessed. There is no external examination linked to this qualification, however you will be required to complete internal theory knowledge test for understanding and knowledge.

1 x Theory assignment

3 x Practical observations (assessments will be conducted during observations).

1 x Theory written knowledge test.

10 x Practical treatment case studies (to be completed within 3 months).

**Time:** To be confirmed by tutor

**Duration:** 1.5 Days

Each learner is required to create a portfolio of evidence which demonstrates achievement of all the learning outcomes and assessment criteria associated with each unit.

The main pieces of evidence for the portfolio could include;

- Assessor observation
- Witness Testimony
- Learner product
- Worksheets
- Assignments/projects/reports
- Record of oral and written questioning
- Learner and peer reports
- Recognition of prior learning (RPL)

### **Learning and assessment processes:**

Assessor support by Video/ conference link, email, telephone, texting.

Certain criteria of evidence for your Level 4 Certificate in Dermaplaning Treatments (RQF) QRN: 603/5587/6, will be gathered remotely, therefore, ideally the following technology should be available for you to access:

- A computer/laptop
- Access to the internet
- Skype/zoom and a webcam
- Flip cam/video/smart phone or camera for evidence gathering the main pieces of evidence for the portfolio include:

Structuring the portfolio of evidence should commence at the earliest point of building your evidence and not at the end of the course.

Evidences should be documented in the portfolio and cross referenced to unit outcomes.

- IQA – all relevant documentation
- Assessor observation – completed observational checklists on related action plans

- Witness Testimonies
- Written Questions
- Oral Questions
- Case Studies
- Learner product
- Worksheets
- Assignments / projects / reports
- Record of oral and written questioning
- Learner and peer reports
- Audio-visual media
- Recognition of prior learning (RPL)

**Grading:** This qualification is graded on a pass or fail basis. Learners must achieve the number of credits stated within the qualification structure.

- Focus Awards Level 4 Certificate in Enhancing Eyebrows with Microblading Techniques (RQF)
- Focus Awards Level 4 Diploma in Managing a Salon Business (RQF)

**Learning Paths:** Flexible blended learning (To be discussed and agreed prior to course enrolment. You will work independently and with the support of your assessor to gather the evidences. All knowledge tasks will be completed within a timely manner (this will be outlined within the course structure.

**Professional presentation:** A full professional therapist uniform, full white or black shoes, hair tied back and secured away from the face, short manicured nails, minimal jewellery (wedding band and stud earrings).

**Course Fees:** £1000.00 (Including registration and learning resources)

**Deposit:** £500.00 to be paid at time of enrolment

**Balance of course fee:** To be paid two weeks prior to course date (last minute bookings to be paid in full)
