ELDER ABUSE FACT SHEET

NEGLECT: Failure of a person to care for an older or dependent adult in a manner that keeps the older or dependent adult healthy and safe from harm. The care provider can be paid or unpaid. For example: Not providing food, clothing, shelter, medicine, assistive devices, and transportation to medical appointments.

SELF-NEGLECT: When an older or dependent adult is unable or unwilling to care for him or herself. For example: Hoarding, drug or alcohol abuse, not taking prescribed medications, not eating, not bathing, not taking care of medical needs, and not paying rent and other bills.

EMOTIONAL ABUSE: Harming the self-worth or emotional well-being of an older or dependent adult by causing fear, anguish, agitation, or other emotional distress. This may include name calling, shouting, and belittling language.

PHYSICAL ABUSE: The non-accidental infliction of harm on an older or dependent adult. This may include physical force that results in or could have resulted in bodily injury, physical pain, or impairment. For example: Hitting, burning, restraining, under or over-medicating, and sexual assault.

FINANCIAL: The illegal or improper use of an older or dependent adult's money, property, or assets. This may include taking out loans on a property, changing an estate plan, or selling unsuitable financial products or services.

Who are the possible Preparators? Family, Outside Caregivers, Professional Perpetrator, Corporate Indicators of Possible Financial Abuse:

- Money missing from bank account,
- money spent on inappropriate items (i.e. not for the benefit of the older or dependent adult),
- bills or rent going unpaid; utilities turned off.
- Changes in Financial Habits: unusual or frequent cash withdrawals from ATM, bounced checks, missed
 credit card payment, purchase of unsuitable products or services, inability to pay rent or mortgage,
 leveraging or taking out loans on property, change to wills or trust, change to home title
