This notice explains how we collect, use, and store your personal information when you instruct us to let or manage your property.

Who We Are

Northgates Letting Agency is the data controller responsible for your personal data.

What Information We Collect

We may collect and process the following data:

- Identity Data (name, date of birth)
- Contact Data (address, email, telephone number)
- Property Data (details of your property and tenancy arrangements)
- Financial Data (bank details, rental income, payment records)
- Compliance Data (certificates, legal documentation)
- Communication Data (emails, calls, instructions, correspondence)



How We Use Your Data

We use your personal data to:

- Market and let your property
- Source and reference tenants
- Prepare tenancy agreements and documentation
- Collect and remit rent
- Arrange repairs, maintenance, and inspections
- Manage compliance with legal obligations
- Communicate with you regarding your property and tenancy

Lawful Basis for Processing

We process your data under:

- Performance of a contract
- Legal obligations
- Legitimate interests (running our business and managing your property)

Who We Share Your Data With

We may share your data, where necessary, with:

- Prospective and approved tenants
- Referencing providers
- Deposit protection schemes
- Contractors and maintenance providers
- Utility providers and local authorities
- Legal, regulatory, or government bodies
- Accountants or professional advisers
- HM Revenue & Customs (where required by law)

We only share your data where necessary and proportionate.

Data Security

We take appropriate measures to protect your personal data and restrict access to authorised individuals only.

Data Retention

We retain your data for as long as necessary to provide our services and comply with legal obligations, typically for **up to 7 years** after the end of the tenancy.

Marketing

We may contact you with information about our services or updates relevant to your property.


You can opt out of marketing communications at any time.

Your Rights

You have the right to:

- Access your personal data
- Request correction of inaccurate data
- Request deletion (where applicable)
- Object to processing
- Restrict processing in certain circumstances
