Key points:

- Peace of Mind cap price will be billed when the current price exceeds cap price.
 - Ex: Heating Oil - Current Market Price \$3.00 Invoice Price \$3.00, Current Market Price \$5.00 Invoice Price \$4.59
- Any specially requested deliveries on or off the contract will result in a delivery fee. We will NOT fill cans, barrels, drums, or any type of temporary tank or storage container.
- Delinquent accounts will void this agreement, and sign-up fees will not be refunded.
- The pricing contract period runs from September 1, 2026, through August 31, 2027.
- **Propane:** We only deliver to customer-owned tanks with a minimum tank size of 120 gallons and tank monitor owned by Susquehanna Oil and Propane.
