HOW LONG HAVE YOU BEEN A MEMBER OF OZARK ELECTRIC?Over 30 Years.

I hope to use my 42 years of management experience in the rural electric cooperative industry to offer the Board and Management of the Cooperative alternative perspectives on issues related to governance, management, operations, finance, and rate making.

WHAT SKILLS DO YOU POSSESS THAT YOU BELIEVE WILL BE AN ASSET TO THE BOARD OF DIRECTORS?

I have over 42 years of management experience in the rural electric cooperative industry. Most of the experience was as the CEO of cooperatives located in three different states.

WHAT DO YOU SEE AS THE PRIMARY WORK OR ROLE OF THE BOARD?

There are five primary functions of the Board:

- 1. Hire, equip, and manage the CEO.
- 2. Work with management to establish the strategic direction of the Cooperative.
- 3. Work with management to develop annual work plans and budgets to support that work.
- **4.** Work with management to develop and implement policies and procedures designed to help the Cooperative achieve its goals.
- **5.** Exercise sufficient oversight to ensure adherence to the functions listed above.

WHAT DO YOU SEE AS THE GREATEST CHALLENGE OR TOP PRIORITY AT THE TIME FOR OZARK ELECTRIC?

Regain the trust and confidence of the membership.

ARE YOU COMFORTABLE INTERACTING WITH THE COMMUNITY AND RECEIVING FEEDBACK/INPUT FROM MEMBERS?

Yes, I am.

HOW WILL YOU HANDLE PUSHBACK FROM MEMBERS ON DIVISIVE ISSUES OR DECISIONS?

I find that by first educating members on issues related to a possible decision followed by carefully listening to member feedback helps to avoid significant pushback.
