

REGULAR SESSION
DECEMBER 15, 2025

The Board of Nemaha County Commissioners met in regular session on Monday, December 15, 2025 in the Commissioner's Room of the Nemaha County Courthouse. The meeting was called to order with Chairman Jason Koch leading the flag salute. Present also were Commissioners Ben Glace and Joe Dalinghaus, and County Clerk Mary Kay Schultejans recording the minutes.

Jason Koch led those present in an opening prayer to begin the meeting this morning.

The board set the agenda for today's meeting. Ben Glace moved to approve the agenda for December 15, 2025 as presented. Joe Dalinghaus seconded the motion. The motion carried with all voting aye.

The board reviewed the minutes from the December 8, 2025 meeting. Joe Dalinghaus moved to approve the minutes as amended. Ben Glace seconded the motion. The motion carried with all voting aye.

Chairman Jason Koch called for Open Public Forum to begin at 9:22 am. No one came before the board to speak during today's forum. Chairman Jason Koch ended public forum at 9:29 am.

Jason Koch moved to approve for publication the 2025 Budget Amendments as presented. Joe Dalinghaus seconded the motion. The motion carried with all voting aye.

Accounts Payable Clerk Donna Meader came before the board to share information with Commissioners concerning the results of past Nemaha County Worker's Compensation audits.

Commissioners called and spoke to County Counselor/County Administrator Austin Parker about the contract for Vance Brothers for the micro-surfacing of Old Highway 9 and about the auto renewal of the contract with KWORCC for 2026 for the county's Worker's Compensation insurance. Notification of requote would need to happen by the end of April 2026 for the 2027 fiscal year.

Ben Glace moved to approve the contract with Vance Brothers for the micro-surfacing of a 5.5-mile stretch of Old Highway 9. This is being used as a test strip as a possible alternative to chip and sealing. Any extra material following this process will be used for blade patching. Joe Dalinghaus seconded the motion. The motion carried with all voting aye.

Joe Dalinghaus moved to approve a transfer of \$25,000 from the funds earmarked for the Sheriff's Office in Capital Outlay to the Law Enforcement Center Fund and \$25,000 from the Courthouse General Account to the Law Enforcement Center Fund with the understanding that the General Fund is to be reimbursed first with any remaining funds at the end of the year. Ben Glace seconded the motion. The motion carried with all voting aye.

Appraiser Kerri Koch came before the board to discuss with Commissioners the county's current Neighborhood Revitalization Plan.

Jason Koch moved to approve the add/abate orders for 2025 as presented. Joe Dalinghaus seconded the motion. The motion carried with all voting aye. Chairman Jason Koch signed the add/abate orders as presented.
