State of Kansas election law now requires every voter in Nemaha County to provide identification before voting.

Advance voter ballots are available by contacting the election office by phone, by mail, or in person for an application. Applications can be downloaded at the Nemaha County website www.nmcoks.us. The last day for sending ballots from the office is Tuesday, July 28th. Advance voter ballots may be voted in the election office until 12:00 noon on Monday, August 3rd. Ballots for Sick or Disabled voters may be applied for until 7:00 p.m. on election day. All advance voter ballots must be returned to the election office by 7:00 p.m. on Election Day, Tuesday, August 4th.
