## The Clinic extends winning streak of national quality awards

ADA – The Clinic continues to earn national accolades for its superior healthcare practices across the board, earning the Health Resources and Services Administration's elite "Health Center Quality Leader" for the second consecutive year.

The Health Resources and Services Administration (HRSA) is the federal agency that funds and regulates community health centers. The Clinic is one of only two such centers in Oklahoma to earn this sought-after HRSA certification in 2025.

The Clinic repeated that achievement and also earned the "Improving Health Care Access" award again in 2025.

"HRSA certifications are challenging to earn," Massey said. "They symbolize to our patients and to the public as a whole that we are dedicated to ensuring they always have the best possible healthcare experiences with us. These awards apply to The Clinic, The Women's Clinic, The Kids Clinic, and The Pharmacy – truly a team effort.
