AND PROCEDURE - 2025

### VIR DIE AANDAG VAN ELKE SAOU-LID

#### 1. VERKIESINGSREGULASIES:

- NB! Slegs betalende SAOU – lede mag deelneem aan die nominasie- en verkiesingsproses. Dit beteken dat studente, interns en lewenslange lede nie deelneem aan hierdie proses nie.
- Die verkiesing van SAOU- lede tot die Provinciale Uitvoerende Raad word bepaal deur die SAOU Grondwet. ([Klik hier om die Grondwet te besigtig](#))
- Alle prosesse en relevante verkiesingsdokumentasie sal geverifieer en bekratig word deur 'n onafhanklike ouditeursfirma. Die besonderhede van die Ouditeursfirma kan bekomm word via die Provinciale Sekretaris.
- Lede word weereens daarop gewys dat die hele verkiesingsproses elektronies sal geskied.
- Lede het toegang tot die skakels wat deel uitmaak van die verkiesingsproses via die nuusbriewe. Lede se ID-nommers sal geverifieer word om lidmaatskap te bevestig. Slegs geverifieerde lede se nominasies en stemme sal in ag geneem word.
- Lede mag enige ander SAOU-lid benoem vir diens op die Provinciale Uitvoerende Raad.
- Lede is ingedeel in 'n spesifieke kring ([sien skakel](#)) in die provinsie, soos vasgestel deur die Provinciale Uitvoerende Raad, volgens die bepalings van die SAOU-grondwet. Daarvolgens sal elke lid dus net kan stem vir die genomineerdes in dieselfde kring. Stemme wat in die verkeerde kring gemaak word, sal nie in ag geneem word nie.
- Dit is belangrik om te onthou dat indien daar meer as 3 kandidate in 'n spesifieke kring benoem word, slegs 3 kandidate gekies kan word.
- Dit sal raadsaam wees om dadelik vir al drie u gekose kandidate te stem. Indien u meer as een maal u stem indien sal slegs die eerste stem in ag geneem word.
- Indien daar slegs 3 genomineerdes vir 'n spesifieke kring ingedien is, sal daardie 3

### FOR THE ATTENTION OF EVERY SAOU MEMBER

#### 1. ELECTION REGULATIONS:

- NBI! Only paying SAOU members may participate in the nomination and election process. This means that students, interns and lifelong members do not participate in this process.
- The election of SAOU members to the Provincial Executive Council is determined by the SAOU Constitution. ([Click here to view the Constitution](#))
- All processes and relevant election documentation will be verified and validated by an independent auditing firm. The details of the Auditing Firm can be obtained via the Provincial Secretary.
- Members are once again reminded that the entire election process will take place electronically.
- Members have access to the links that are part of the election process via the newsletters. Members' ID numbers will be verified to confirm membership. Only verified members' nominations and votes will be taken into account.
- Members may nominate any other SAOU member to serve on the Provincial Executive Council.
- Members are divided into a specific circuit ([see link](#)) in the province as determined by the Provincial Executive Council, according to the provisions of the SAOU constitution. According to this, each member will only be able to vote for the nominees in the same circuit. Votes casted in the wrong circuit will not be taken into account.
- It is important to remember that if more than 3 candidates are nominated in a specific circuit, only 3 candidates can be elected.
- It would be advisable to vote for all three of your chosen candidates immediately. If you submit your vote more than once, only the first submission will be taken into account.
- If only 3 nominees have been submitted for a specific circuit, those 3 nominees will automatically pass as elected to that circuit.
- In the case mentioned above, it will therefore not be necessary for the members in that circuit to vote. The link will automatically close with a

NOMINATION PROCESS:</b></p> <ul style="list-style-type: none"> <li>A friendly appeal is made to SAOU workplace representatives, principals and SAOU members to adhere <b>strictly to the due dates</b>.</li> <li><b>Links to the nomination form are included at the bottom of this newsletter.</b></li> <li>When you nominate a candidate, you will have to nominate a seconder as well and then supply both the nominated candidate as well as a seconder's cell numbers or email addresses. The nominated seconder will then receive a link to second.</li> <li>After that, the nominated candidate will also receive a link with which he / she accepts the nomination and if so, also complete an abridged CV and send a head and shoulders photo of himself or herself to the provincial SAOU office.</li> <li>Nominations will be submitted electronically by SAOU members from 25 August to 4 September 2025.</li> <li>The nomination, secondment and acceptance forms are submitted electronically via links provided in newsletters. None of the above documentation can be submitted after 4 September.</li> <li>Any objection that a member wishes to file against this process must be sent to <a href="mailto:elections@saou.co.za">elections@saou.co.za</a> on or before 4 September 2025. The nature of the objection must be clearly stated and motivated in the email. A member who objects must please indicate the province and circuit very clearly. No anonymous objections will be accepted.</li> <li>Each institution's SAOU Workplace representative must closely monitor this process and remind members of deadlines so that they are adhered to.</li> </ul> <p>The Provincial Office processes the information and sends the information of the nominated candidates with a short CV to members on 10 September 2025 by Election Newsletter 3</p>
