| TERMINATION OF AGREEMENT: The Buyer agrees that EBIKES4AFRICA has the right to terminate this agreement at any time and to retake possession of sequipment, and for said purpose EBIKES4AFRICA may enter upon the premises of the Buyer without becoming liable for trespass. |
| COLLECTION COMMISSION: All costs and disbursements, including legal costs on an attorney and own client scale, incurred by EBIKES4AFRICA in collecting endeavouring to collect all or any amounts payable by the Buyer to EBIKES4AFRICA or otherwise and all collection commissions and all other charges of a like nature payable by the Buyer to EBIKES4AFRICA on demand. |
| INTEREST: Should the Buyer fail to pay on or before the due date any amount failing due or payable to EBIKES4AFRICA under or arising from this agreement, the without prejudice to such rights as may accrue to EBIKES4AFRICA consequent upon such failure, such overdue amounts shall bear interest at the prime overdraft charged from time to time by EBIKES4AFRICA's banker. |
| JURISDICTION TO MAGISTRATE COURT: The Buyer hereby consents to the jurisdiction of the Magistrate's Court having jurisdiction over the person in respect on action by EBIKES4AFRICA arising from this Agreement or cancellation thereof. |
| DEBIT ORDER MANDATE: In the event that the outstanding debt is not settled, for any reason, the Buyer mandates EBIKES4AFRICA or its Cessionary to collect amount owing in either one lump sum or monthly installments from the Buyer's bank account by means of a debit order. This mandate shall constitute a valid debit or which debit order shall automatically apply and EBIKES4AFRICA or its Cessionary shall be authorised to collect the installments/lump sum by means of the said debit or from any of the Buyer's bank accounts. The Buyer further consents to the tracing of such banking details should the banking details as provided by the Buyer be incoror no longer relevant. |
