These items are covered by Hanke Bothers for one (1) year only. Any manufacturer's warranty of these items may apply only under the terms specified in their coverage.

*The K-Guard Covered Gutter System includes a lifetime guarantee against clogging (water stoppage **INSIDE** the system) provided the system is not altered or tampered with in any way. **This clog free guarantee does not include the cleaning of the outside extremities** of leaves, pine needles, tree bark or mulch that may have collected due to high wind or runoff from the roof; it is the homeowner's sole responsibility to make sure their roof and outer K-Guard extremities are clean and free of debris

IF THE IMPROVED HOME IS SOLD, THIS GUARANTEE MAY EASILY BE TRANSFERRED TO THE NEW OWNER. THIS GUARANTEE MAY BE TRANSFERRED BY FILLING OUT THE TRANSFER REQUEST BELOW WITHIN 90 DAYS OF CLOSING AND ENCLOSING A \$500.00 TRANSFER FEE.
